Memorandum

This Office is in cognizance of the letter for protest by Confederation of Central Government Employees and Workers dated 23/01/2026 addressed to the Cabinet Secretary, wherein it has been informed that the employees who are members of the affiliated organization of the Confederation of Central Government Employees and Workers will go on a One day strike on 12th February, 2026.

2. In this connection, reference is invited to the DoPT's Instruction issued vide F.No.33012/1(s)/2008-Estt(B)(Pt) dated 12/09/2008 which prohibits Government Servants from participating in any form of strike including mass casual leave, go-slow etc., or any action that abet any form of strike will be in violation of Rule 7 of CCS(Conduct)Rules, 1964. The right to form an Association does not include any guaranteed right to strike. Going on strike is a grave misconduct under the Conduct Rules and that misconduct by the Government employees is required to be dealt with in accordance with the law. Any employee going on strike in any form will be taken serious note of and those concerned would face the consequence which besides deduction of wages, may also include appropriate disciplinary action.

03. Therefore the action in instances of violation of discipline and conduct rules would be taken in accordance with the instruction on the subject.

04. This is issued with the approval of the Chief Commissioner of Customs (Preventive) Zone, Tiruchirappalli.
