**MINUTES OF THE SPECIAL WEEKLY CCFC MEETING HELD ON
20.08.2026 at 15.30 Hrs.**

Based on the Board's instructions, a special weekly CCFC Meeting to review Import-Export related issues in view of the prevailing global situation (Gulf Crisis) and SCMTR weekly outreach programme to sensitize all stake holders about the provisions of the smooth implementation of SCMTR, 2018 was conducted on 20.08.2026 at 15:30 hrs. at the Conference Hall, Tiruchirappalli Customs (Preventive) Zone, Trichy in hybrid mode for the convenience of the trade, under the Chairmanship of Shri P.V.N Suresh Babu, Chief Commissioner of Customs, Tiruchirappalli (Preventive) zone.

The CCFC meeting was attended by the Officers of the Chief Commissioner of Customs, Tiruchirappalli (Preventive) Zone, Trichy Customs (Preventive) Commissionerate and Tuticorin Customs House Commissionerate and other members/stake holders falling under the Jurisdiction of the Zone. 3. The Joint Commissioner, CCO, Tiruchirappalli welcomed all the attendees. The following point put forth by the trade were taken up for discussion.

(i) Shri Amalan, Sr.GM, CONCOR India Ltd

SCMTR – Pending EGM/Stuffing Reports: Shri Amalan, Sr.GM, CONCOR India Ltd. raised the issue of technical difficulties in filing/transmission of Stuffing (SF) Messages under SCMTR, resulting in backlog of stuffing reports. It was also stated that the SCMTR implementation period/time limit is not yet over and that EGM pertaining to the previous period could not be filed. He further requested that the system may be kept open/enabled for some time to facilitate filing of the pending EGM and clearance of the backlog at their

Tuticorin Terminal.

Reply: -The matter was noted by the Chairman and CONCOR was advised by the Chairman to furnish the specific details of the pending cases and system error/rejection for examination to Pr. Commissioner, Custom House, Tuticorin.
