**MINUTES OF THE SPECIAL WEEKLY CCFC MEETING HELD ON**  
**27.08.2026 at 15.30 Hrs.**

Based on the Board's instructions, a special weekly CCFC Meeting to review Import-Export related issues in view of the prevailing global situation (Gulf Crisis) and SCMTR weekly outreach programme to sensitize all stake holders about the provisions of the smooth implementation of SCMTR, 2018 was conducted on 27.08.2026 at 15:30 hrs. at the Conference Hall, Tiruchirappalli Customs (Preventive) Zone, Trichy in hybrid mode for the convenience of the trade, under the Chairmanship of Shri Devandar V.Nagvenkar, Principal Commissioner of Customs, Custom House, Tuticorin, Tiruchirappalli (Preventive) zone.

2. The CCFC meeting was attended by the representatives of the Officers of the Chief Commissioner of Customs, Tiruchirappalli (Preventive) Zone, Officers of Trichy Customs (Preventive) Commissionerate and Tuticorin Customs House Commissionerate and other members/stake holders falling under the Jurisdiction of the Zone. The details of the same are attached vide Annexure-A.

3. Shri. Sree Hari Sankar P, Additional Commissioner, CCO, Tiruchirappalli welcomed all the attendees. The following points put forth by the trade were taken up for discussion.

**(i) Shri. Srinivasan, Tirupur Exporter Association-**

**Delay in Generation of Stuffing Reports at Tirupur/Tuticorin CFSs:**

Shri Srinivasan, Representative of Tirupur Exporters Association, highlighted the pendency in generation of Stuffing Reports for Shipping Bills at various CFSs in the Tirupur/Tuticorin region, reportedly due to SCMTR-related technical issues. He stated that the delay was affecting transmission of Shipping Bills to AD Code Banks/EDPMS, resulting in delays in EGM/EDPMS closure and realization of export proceeds, besides

affecting exporters' claims of Duty Drawback/RoSCTL. He requested expeditious resolution of the technical issues and clearance of the pending Stuffing Reports.

**Reply:** -The matter was noted by the Chairman and Tiruppur exporter Association was advised by the Chairman to furnish the specific details of the pending cases to Commr, Trichy Customs (P) and Pr. Commr, CH, Tuticorin

**(Action: - Custom House, Tuticorin & Trichy Customs(P) Commissionerate)**

**(ii) Shri S Kandasamy, CONCOR CFS Tuticorin**

**SCMTR – Pending EGM/Stuffing Reports:**

He brought the attention towards the requirement under the recent Circular No. 16/2026 dated 30.03.2026 issued in connection with the Sea Cargo Manifest and Transshipment Regulations (SCMTR), wherein the responsibility for filing of Stuffing Report has been assigned to the Custodians (CFS). He stated that since 01.07.2026 Stuffing Reports are not filed by Custodians due to some technical issues, so the shipping bills are pending in EGM, that even after the stuffing reports have been entered, many Shipping Bills continue to remain in the EGM Error Queue with error code "Q." He further stated that as a result, a significant number of Shipping Bills are reflecting EGM related errors, adversely affecting the timely processing of export incentives and other export benefits. He requested that necessary instructions may be issued for proper implementation as per SCMTR by custodians and to arrange for alternate solution to post stuffing report till the issue is resolved.

**Reply:** -The matter was noted by the Chairman and CONCOR was advised by the Chairman to furnish the specific details of the pending cases and system error/rejection for examination to Pr. Commissioner, Custom House, Tuticorin

**(Action: - Custom House, Tuticorin)**

**(ii) Shri. V. Minesh Raja, ACT Link Logistics Pvt. Ltd,**

**Drawback Scroll Status and EGM Errors – Madurai Air Cargo-**

The members brought to the notice that certain Shipping Bills pertaining to Madurai Air Cargo are presently reflecting the status "**DBK Scroll In**". It was requested that the necessary action may be taken to process the same to "**Scroll Out**" and generate the corresponding **Scroll Number** to facilitate release/payment of the Drawback amount.

It was further brought to the notice of the Committee that three (3) Shipping Bills are presently reflecting EGM errors. The concerned jurisdiction was requested to examine and rectify the EGM errors at the earliest so as to enable clearance of the said Shipping Bills

and facilitate timely processing of the admissible export benefits.

**Reply:** - The matter was noted by the Additional Commissioner of Customs (P), Tiruchirappalli Commissionerate. Specific details were sought from Shri V. Minesh Raja, ACT Link Logistics Pvt. Ltd., with a direction to take up the matter with the concerned section and facilitate its early resolution.

**(Action: -Trichy Customs(P) Commissionerate)**
