Sub : Draw of panel of eligible Superintendents for panel posting to Customs Airport Trichy (excluding Air Cargo) for the year 2014-16 - Reg.

\*\*\*\*\*

It is proposed to draw panel for posting of Superintendents to Customs Airport Trichy (excluding Air Cargo) for the year 2014-16 and the tenure of Airport is fixed as 02 years.

2 The minimum eligibility conditions for officers to express willingness for the above panel posting have been fixed as follows, strictly as a one-time measure.

Qualifying Service in the cluster Commissionerate in that cadre	2 Years
Cooling-off period after Deputation like DRI, NCB, etc.,	2 Years
Cooling-off period after repatriation from CH Tuticorin	2 Years
Reposting to Trichy Airport (or) from any other International Airport	3 Years

3. The conditions relating to cooling-off period after completion of identified sensitive postings like ICD/CFSS at Pondy/Arakkonam/Karur, CH Pondy and Karaikal Port is waived fully, as a one-time measure.

4 Officers applying for second time posting will be considered only in case of adequate numbers of officers not available for first time posting and will be listed in the order of date of relief from Airport, Trichy / any international Airport, irrespective of their seniority.

5. The officers, who have completed the prescribed station tenure in their present place of posting alone, are entitled for transfer benefits for their posting to Airport Trichy. The posting and transfer benefits for the officers repatriating from Airport Trichy will be made as per the Note order dated 30/03/2005.

6 The eligibility date for drawal of the panel is fixed as 30/06/2014. The Panel would be drawn from the officers satisfying the above conditions and on their Seniority cum Vigilance clearance cum suitability adjudged by the competent authority.

7 The willingness of the officers as per the proforma enclosed, should reach this office on or before **24/03/2014** and no application will be entertained after that date. Willingness once exercised is final and officers are not allowed to withdraw their applications at a later date and if so, the officer will be debarred from applying for Airport panel posting for next 3 years. The Commissioner of Central Excise, Trichy and CC (P)'s office are requested to forward such applications along with vigilance status of the officers on that date as per Note order dated 30/03/2005, within the stipulated time.
