**CIRCULAR**

Sub : Drawal of additional panel of Superintendents & Inspectors for Posting to Customs Commissionerate, Tuticorin during the year 2014-15 - Calling for written requests from eligible officers – Reg.

\*\*\*\*\*

**It is proposed to call for additional panel with relaxed norms with the approval of the CC(P) Trichy, to fill up the vacancies arose due to promotions effected on cadre restructuring.** Hence, willingness may be submitted by eligible Superintendents & Inspectors for consideration of panel posting to Custom House, Tuticorin during the year 2014-15 on SP 03 RB.

2 The minimum eligibility conditions for officers to express willingness for the above panel posting have been fixed as follows as a one-time measure:

**SUPERINTENDENTS & INSPECTORS**

Minimum Qualifying Service in the cluster Commissionerate in that Cadre	1 Year
Cooling-off period after Deputation like DRI, NCB, etc.,	Waived
Cooling-off period after ICD, CFS, CH Pondy, Karaikal Port	Waived
Cooling-off period after Trichy Airport / any International Airport	1 Year
Reposting to CH, Tuticorin (when no officer of the respective cadre is available for first posting)	2 Years

3. Officers applying for Reposting will be considered only if adequate numbers of officers are not available for first time posting and will be listed in the order of their date of relief from Customs Commissionerate, Tuticorin irrespective of their seniority /period worked at Tuticorin.

4. The officers, who have completed the prescribed station tenure in their present place of posting alone, are entitled for transfer benefits for their posting to Custom House, Tuticorin. The repatriation of officers on completion of SP 03 RB tenure and transfer benefits will be made as per the Administrative order 01/2008 dated 01/04/2008.

5 The eligibility cut-off date for drawal of the panel is fixed as 31/12/2014 and the officers fulfilling the above stipulated conditions and who furnish their willingness will be listed based on their Seniority cum Vigilance clearance cum suitability adjudged by the competent authority.

6. The willingness of the officers, as per the proforma enclosed, should reach this office on or before 16/12/2014 and no application will be entertained after that date. An option once exercised by officers for SP 03 RB posting is final. They will not be allowed to withdraw their willingness at a later date. The Commissioner of Central Excise, Trichy and CC (P)'s office are requested to forward such applications along with vigilance status of the officers, as per Admn. Order dated 01/2008 dt. 01/04/2008, within the stipulated date.
