## TENDER - CUM - AUCTION NOTICE No. 02/2015

Sealed Tenders are invited by the Assistant Commissioner of Customs, Customs Division, Ramanathapuram on behalf of the Commissioner of Customs, Trichy from interested parties for the Auction of the goods listed in the Annexure to this Notice to be held at 15.00 hours on 04.11.2015 subject to the following conditions:

- 02. Separate sealed Tenders on plain paper should be submitted quoting the price indicating the serial number of the goods mentioned in the Annexure for each item. The Tender price should be exclusive of all Taxes, Central or State, wherever applicable.
- 03. The Earnest Money Deposit [EMD] of Rs 5,000/- [Five Thousand Only] in the form of Cash may be deposited at the time of submitting the Sealed Tender. The EMD amount received from unsuccessful Tenderers will be refunded to them on 04.11.2015 itself.
- 04. Sealed Tenders will be received at the Office of the Assistant Commissioner of Customs, Customs Division, Ramanathapuram up to 14:00 Hrs. on 04.11.2015 and will be opened in the presence of the Tenderers at 15:00 Hrs. on 04.11.2015 itself. If there are Corrections/over-writings/additions or deletions in the Tender the same are liable for rejection.
- 05. If the Tender price is not acceptable, Open Auction among the Tenderers only will be conducted on the same day.
- 06. The goods may be inspected by the prospective Tenderers at the Office/places mentioned at Column 5 of the Annexure to this Notice during normal Office hours on all working days prior to the date of Auction.

- Only the highest bid will be accepted and the successful Tenderers/Bidders shall be required to pay 25% of the Tender value/Bid amount by Cash on the spot on acceptance, including provisional acceptance. The remaining amount with appropriate Sales Tax/VAT and Surcharge, if any, has to be paid within seven days of the date auction/intimation of final acceptance, in case of provisional acceptance failing which the 25% advance amount already collected will be forfeited to Government without any notice. Apart from the sale value, all purchase, sale and other Central, State and local Taxes, if any, that may be levied shall be payable by the successful Tenderers/Bidders.
- 08. The goods shall remain in the custody of the Department in every respect at the risk of the Bidder from the date of acceptance, including provisional acceptance of the bid and the Government shall not be under any obligation for safe custody or the preservation there from the date of acceptance including provisional acceptance.
- When the purchaser is not given delivery of the goods for any unforeseen reasons after acceptance of bid, he shall not be entitled to make any claim for damage, loss/profit or compensation on any account.
- Whenever any claim for the payment of sum of money to the Government arises out of or under anction sale against the buyer, the Government shall without prejudice to any other remedy, be entitled to deduct such sum of money at any time thereafter from any sum that may become due to the buyer under any contract with the Government and this is not sufficient to cover the full amount recoverable. The buyers shall pay to the Government on demand the balance remaining due.
- All disputes arising out of or in any way touching or concerning the agreement for sales whatsoever shall be referred to the sole arbitration of the Commissioner of Customs, No. 1, Williams Road, Cantonment, Trichy or any person nominated by him. It shall not be objected that the arbitrator is a Government servant that he had to deal with all or any other matter in dispute. The decision of such arbitrator shall be final and binding on parties to the agreement.
- 12. The department reserves the right to reject any or on all Tenders/Bids without assigning reasons thereof. The Department also reserves the right to withdraw any or all goods from the Tender/Auction without assigning any reasons. The decision of the Assistant Commissioner will be final in this regard.
- 13. Sale of goods is purely on 'AS IS WHERE IS' condition basis. The goods shall be taken from the site with all faults or errors in description or otherwise, quantities, size, measurement,

number, weight as stated in the lots. No warranty or guarantee shall be implied. The above goods are sold on the assumption that the bidders have inspected the lots and know what they are buying. The principle of 'caveat emptor' will apply and no complaint will be entertained after the sale.
