TENDER CUM AUCTION NOTICE 01/2015

Sealed tenders are invited on behalf of the Commissioner of Customs, Trichy by Assistant Commissioner of Customs, Customs Division, Nagapattinam from the interested parties for the Tender cum Auction sale of the goods listed in the Annexure to this notice to be held at 13.00 hours on 19-02-2015 subject to the following conditions, at the office of the Assistant Commissioner of Customs, Customs Division, Nagapattinam in the above mentioned address.

- 2. Separate sealed tenders on plain paper should be submitted quoting the price indicating the serial number of the goods mentioned below for each items. The tender price should be read exclusive of all taxes, central or state wherever applicable.
- 3. The earnest money deposit (EMD) of Rs. 10,000/-, may be deposited at the time of submitting the sealed tender for each item in cash.
- 4. The sealed tender will be received at the office of the Assistant Commissioner of Customs, Customs Division, Nagapattinam up to 14.00 Hrs. on the auction date and the same will be opened in the presence of the Tender at 14.30 Hours on the same day (19.02.2015). Corrections/over-writings/additions or deletions in the Tender are liable for rejection.
- 5. If the tender price is not acceptable, open auction will be conducted on the same day and only the tenderers will be allowed to participate in it.
- 6. The goods may be inspected by the prospective tenderers at the place mentioned at Column 5 of the list during normal office hours on two days prior to the date of auction.
- 7. Only the highest bid will be accepted and successful tenders/bidders shall be required to pay 25% of the tender value/bid amount by cash on the spot on acceptance, including provisional acceptance. The remaining amount with appropriate sales tax and surcharges if any, has to be paid within seven days of date of auction/intimation of final acceptance in case of provisional acceptance, failing which the 25% advance amount already collected will be forfeited to the Government. Apart

from the sale value, all purchase, sale and other State and local taxes and other charges if any shall be payable by the successful tenders/ bidders.

- 8. The goods shall remain in the custody of the Department in every respect at the risk of the bidder from the date of acceptance, including provisional acceptance of the bid and the Government shall not be under any obligation for the safe custody or the preservation thereof from the date of acceptance including provisional acceptance.
- 9. When the purchaser is not given delivery of the goods sold for any unforeseen reasons after acceptance of the bid, he shall not be entitled to make any claim for damage, loss or profit or compensation on any account.
- 10. Whenever any claim for the payment of sum of money to the Government arises out of or under auction sale against the buyer, the Government shall without prejudice to any other remedy, be entitled to deduct such sum of money at any time thereafter from any sum that may become due to the buyer under any contract with the Government and if this is not sufficient to cover the full amount recoverable. The buyer shall pay to the Government on demand the balance remaining due.
- 11. All disputes arising out of or in any way touching or concerning the agreement for sale whatsoever shall be referred to the sole arbitration of the Commissioner of Customs, No.1 Williams Road, Trichy-1 or any person nominated by him. It shall not be objected that the arbitrator is a Government Servant that he had to deal with all or any other matter in dispute. The decision of such arbitrator shall be final and binding on parties to the agreement.
- 12. The department reserves the right to reject any or all tenders / bid without assigning any reasons thereof. The department also reserves the right to withdraw any or all goods from the tender/auction without assigning any reasons. The decision of the Customs Department will be final in this regard.
- 13. Sale of goods is purely on "AS IS WHERE IS' basis. The goods shall be taken with all faults and errors in description or otherwise, quantities, size, measurement number and weight as stated in the list. No warranty or guarantee shall be implied. The above goods are sold on the assumption that the bidders have inspected the lots and know what they are buying. The Principe of 'CAVEAT EMPTOR' will apply, and no complaint will be entertained after the sale.
