TENDER - CUM - AUCTION NOTICE

The following goods are proposed to be sold by the Assistant Commissioner of Customs, Customs Division, Tuticorin on behalf of the Commissioner of Customs, Tiruchirappalli. Therefore sealed tenders are invited from interested parties for the auction of the goods mentioned below to be held at this office on 04.03.2015.

2. The sealed tenders should be submitted in plain paper quoting the Lot No. and price for the above said goods. The tender price should be read exclusive of all taxes, Central or State wherever applicable.

3. Separate tender should be submitted for each item quoting Lot No. and description of the goods over the outer cover of the sealed tender.

4. The Earnest money Deposit (EMD) of Rs.2000/- (Rupees Two thousand only) for each item in the form of cash may be deposited at the time of submitting the sealed tenders.

5. The sealed tenders should be addressed to the Assistant Commissioner of Customs, Customs Division, No.66, Beach Road, Tuticorin - 628 001 and will be received up to 12.00 Hrs on 04.03.2015 and the same will be opened in the presence of tenderers on the same day at 14.00 Hrs. Tenders which contain any correction or over written or any addition or deletion are liable for rejection.

6. If the tender price is not acceptable, open auction only among the bidders will be conducted at 16.00 hrs on the same day (i.e. on 04.03.2015).

7. The goods may be inspected by the prospective bidders at this office from 23.02.2015 to 03.03.2015 between 14.00 Hrs to 16.00 Hrs on all working days.

8. Only the highest bid will be accepted and the successful tenderers/bidders shall be required to pay 25% of the tender value by cash on the spot on acceptance of the tender by the Assistant Commissioner including provisional acceptance. The balance amount with appropriate Sales Tax/VAT and Surcharge etc, if any, has to be paid within seven days of auction or intimation of final acceptance in case of provisional acceptance, failing which the 25% advance amount already collected will be forfeited to the Government of India without any intimation to the successful tenderers/bidders. Apart from the sale value all purchase,

sale and other Central or State and Local taxes, if any, that may be levied, shall be payable by the successful tenderers/bidders.

9. The goods shall remain in the custody of the Department in every respect at the risk of the bidder from the date of acceptance, including provisional acceptance of the bid and the Government shall not be under any liability for the safe custody or the preservation thereof from the date of acceptance including provisional acceptance.

10. When the purchaser is not given the delivery of the goods for any unforeseen reasons after acceptance of bid he shall not be entitled to make any claim for damage, loss or profit or compensation on any account.

11. Whenever any claim for payment of a sum of money to the Government shall without prejudice to any other remedy be entitled to deduct such sum of money from any sum due or which at any time thereafter may become due to the buyer under any contract with the Government and if this is not sufficient to cover the full amount recoverable the buyer shall pay to the Government on demand the balance due.

12. All disputes and differences arising out of or in any way touching or concerning the agreement for sale whatsoever shall be referred to the sole arbitration of the Commissioner of Customs, No.1, Williams Road, Tiruchirappalli or any person nominated by him. It will be no objection that the arbitrator is a Government servant that he has to deal with all or any of the matters in dispute of difference. The award of such arbitrator shall be final and binding on parties to the agreement.

13. The Department reserves the right to reject any or all tenders/bids without assigning any reasons there for. The Department also reserves the right to withdraw the above said goods from the tender / Auction without assigning any reasons there for. The decision of the Assistant Commissioner is final in this regard.

14. Sale of the above said goods is purely on 'AS IS WHERE IS BASIS' condition. The goods shall be taken from the site with all faults and errors in description or otherwise quantity, size, measurements, number, weight as stated in the list or approximate and no warrantee or guarantee shall be implied. The above said goods are sold on the assumption that the bidders have inspected the above said goods and know that what they are buying. The principle of CAVEAT EMPTOR will apply and no complaint will be entertained after sales.
