Sub: Change of Service Centre Operator - Regarding.

It is brought to the notice of Importers/ CBs/ Members of Trade and all other stakeholders that the competent authority in Directorate of Systems and Data Management, New Delhi, has approved the award of contract to the new vendor, M/s Xeam Ventures Pvt. Ltd., Chandigarh, who will be taking over the facilitations in the service centres with effect from 01.10.2015 from M/s CMC Ltd. (i) The period of contract is fixed as two years starting from 01.10.2015 to 30.09.2017. (ii) Document digitalization charges increased from Rs.60 to Rs.80, and printing charges increased from Rs.20 to Rs.30.

2. I - <u>Maximum service charges for digitalization of documents at service centre;</u> For manual documents getting data entry done at Service Centre.

- (i) Bill of Entry/Shipping Bill having up to five items: Rs.80 (Sharable)
- (ii) Each Additional Block of five items: Rs.10
- (i) IGM: Rs.80 (Sharable)
- (ii) EGM:Rs.80 (Sharable)
- (iii) Other documents (such as UAB, Transhipment, etc.): Rs.80 (Sharable)
- (iv) Amendments to original declaration by customer in BE/SB/Other documents: Rs.10
- (v) Queries (including reply feeding): Nil for 3 queries and Rs.10 for each query thereafter.
- (vi) Printing check list: Nil
- (vii) Printing of assessed documents (SB/BE/OOC/LEO/Challan, etc.): Nil

II - Maximum service charges for 'RES' documents

ICEGATE or any other manner of Remote EDI filing:

- (i) Printing of Document: Rs.30 (for the first 50 pages and Rs.10 for every 10 subsequent pages or parts thereof (documents refers to the set of papers, which get printed in one command at any sage of processing).
- (ii) Query Printing: Rs.10
- (iii) Amendments fee to Bill of Entry (for block of five items): Rs.20
- (iv) Amendments fee to Shipping Bill (for block of five items): Rs.10
- (v) Amendments fee Each Additional block of five items: Rs.10
- (vi) Amendments fee Other documents: Rs.10
- (vii) Printing Check list: Rs.10

Note: The above charges are excluding Service Tax and any other taxes. The vendor shall collect the service tax from trade at the prevailing rates and shall make the payment of the Service Tax to the Govt. Exchequer.
