PUBLIC NOTICE NO. 26/2015

Subject :Nomination of Nodal officers for monitoring realization for export proceeds in EDI under the BRC Module for ICES(introduced in year 2009) and the new RBI BRC Module introduced under DG(Systems) letter dt. 28.08.2014 – Regarding.

Attention of trade/industry and field formations is invited to Board's Circular No. 05/2009.Cus instruction no. 609/119/2010-DBK dt. 18.01.2011. Instruction No. 609/35/2013-DBK dt. 04.04.2013 and para 3 of Instruction No. 603/01/2011-DBK dt. 11.10.2013 which, amongst other aspects, direct the methodical, time bound and monitored feeding of details of realization/non-realization received from exporters/their statutory auditors/banks/RBI in the BRC Module of ICES implemented in year 2009 for achieving complete and effective implementation of the statutory requirement of recovery of drawback with interest with respect of all drawback EDI shipping bills. Board's instruction in F.No.609/59/2012-DBK dt. 27.11.2015 and Public Notice No.23/2015 dt. 01.12.2015 issued by the Commissioner of Customs, Trichy may also be referred in this regard.

- 2. Subsequently, the DG(Systems) letter No. IV(35)/46/2013-Systems dtj. 28.08.2014 has introduced the RBI BRC module to the field formations conveying that this was expected to receive foreign exchange realization data for shipping bills with LEO dates from 01.04.2013 onwards.
- 3. Consequently, for EDI shipping bills with LEO dates from 01.04.2013 to 31.03.2014 the respective filed formations are required to take up the work in terms of the directions referred in para 1 above, in a smooth manner.

- 4. The jurisdictional Assistant Commissioners have been nominated as Nodal Officers for receiving certificate/statements which is to be expeditiously fed in to the BRC Module. The exporters are requested to submit the certificate/negative statements to the concerned field formations not later than 27.01.2016 for all drawback EDI shipping bills with LEO dates from 01.04.2013 to 31.03.2014. The exporters are also requested to submit the documents through direct submission or by post to the concerned Nodal officer. The Joint Commissioner shall be responsible for ensuring that the officers, specially designated by the Commissioner to verify the certificate/statement and to make entries in the BRC Module, complete these duties expeditiously.
- 5. The entire process shall be treated as a special drive with dedicated staff deployments. The Trade/Industry is requested to co-operate with the department for timely closure of pendency.
- 6. If any problem is noticed on implementation of the above procedure, the same may be addressed to Joint Commissioner (Systems), Hqrs, Office, Trichy, for necessary action.
