Shri. J.Karunakaran, **Radio Operator** working at Customs Preventive Unit, Rameswaram under Customs Division, Ramnad, is promoted to the grade of **Supervisor** in the Pay Scale of Rs.9300-34800 in Pay Band 2 Plus Grade Pay of Rs.4200 with immediate effect and posted to the CPU, Rameswaram under Customs Division, Ramnad.

2. The above said officer should assume the charge within a period of 15 days failing which it will be construed that he is not interested in accepting the offer of promotion.

3. His seniority in the cadre strength of Trichy Customs Commissionerate will be fixed in due course as per orders in force.

4. He should exercise his option for fixation of pay as per F.R.22 (I) (a) (1) within one month from the date of joining as Supervisor. However, if he has already been granted the financial benefits under the Assured Career Progression/Modified Assured Career Progression Scheme in the post of Radio Operator, he will not be entitled for the fixation of Pay.
