3. The above Officers shall join in Customs Commissionerates, Tuticorin / Trichy immediately on relief, but not later than 10/07/2015. Further posting of the officers posted to Trichy Customs Commissionerate, will be decided in due course.

4. The maximum period of tenure for officers posted to Tuticorin Custom House will be 03 years from the date mentioned in para 3 above subject to amendments to the Transfer Policy which is underway.
