## CIRCULAR

Sub: Drawal of additional panel from eligible Superintendents & Inspectors for posting to Customs Commissionerate, Tuticorin during the year 2015-16 - Calling for written requests from eligible officers – Reg.

Attention is drawn to Circular of even number dated 13/04/2015. In furtherance to that it is proposed to call for willingness from eligible Superintendents & Inspectors for drawing an additional panel for consideration of posting to Custom House, Tuticorin during the year 2015-16 on Selection Posting of Superintendents / Inspectors to Tuticorin Customs on 03 year Rotation Basis [SP 03 RB].

2. The minimum eligibility conditions for officers to express willingness for the above panel posting have been fixed as follows:

- 3. Officers applying for second time posting will be considered only if adequate number of officers are not available for first time posting and will be listed in the order of their date of relief from Customs Commissionerate, Tuticorin irrespective of their seniority /period worked at Tuticorin.
- 4. The officers, who have completed the prescribed station tenure in their present place of posting alone, are entitled for transfer benefits for their posting to Custom House, Tuticorin. The repatriation of officers on completion of SP 03 RB tenure and transfer benefits will be made as per the Administrative order 01/2008 dated 01/04/2008.

- The eligibility cut-off date for drawal of the panel is fixed as 30/06/2015 and the officers fulfilling the above stipulated conditions and who furnish their willingness will be listed based on their Seniority cum Vigilance clearance cum suitability adjudged by the competent authority.
- The willingness of the officers, as per the proforma enclosed, should reach this office on or before 20./05/2015 and no application will be entertained after that date. Option once exercised by officers for SP 03 RB posting is final and they will not be allowed to withdraw their willingness at a later date.
- 7 Eligible Officers working in Central Excise Commissionerate Trichy and Office of the Chief Commissioner of Customs (Prev.) Trichy should forward their application through proper channel. No application will be considered which is received directly.
- 8 The Commissioner of Central Excise, Trichy and CC(P)'s office are requested to forward such applications along with vigilance status of the officers, as per Admn. Order dated 01/2008 dated 01/04/2008, within the stipulated date.
