Sub: Drawal of additional panel from eligible Superintendents & Inspectors for posting to Customs Commissionerate, Tuticorin during the year 2015-16 - Calling for written requests from eligible officers – Reg.

Ref: Administrative Order No.01/2015 dt. 03 /07/2015 issued by CC(P), Trichy

Attention is drawn to Administrative Order No.01/2015 dt. 03/07/2015 issued by the Chief Commissioner of Customs (Prev.), Trichy, framing a new policy viz., "Policy for Selection & Posting of Officers to Tuticorin Customs" superceeding all the earlier Circulars, Office Orders, Note orders & Standing orders issued in this regard from time to time.

- 2. It is proposed to call for willingness from eligible Superintendents & Inspectors for drawing panel of Superintendents and Inspectors respectively for posting to Custom House, Tuticorin during the year 2015-16 for a period of 04 years in accordance with the aforesaid Administrative order.
- 3. All officers within the cluster Commissionerates and who are free from Vigilance, including officers on promotion to the above grades may apply, with the exception of officers joining the cluster Commissionerates on ICT and those who have completed the tenure in Trichy Airport and Tuticorin Customs, in whose cases a minimum cooling off period of one year has been specified vide para. 4 of the aforesaid Administrative Order.
- 4. The eligibility cut-off date for drawal of the panel is fixed as 30/06/2015. The willingness of the officers, as per the proforma enclosed, should reach this office on or before 20/07/2015 and no application will be entertained after that date. Option once exercised by officers for Tuticorin Panel Posting is final and they will not be allowed to withdraw their willingness at a later date.

- Eligible Officers working in Central Excise Commissionerate Trichy and Office of the Chief Commissioner of Customs (Prev.) Trichy should forward their application through proper channel. No application will be considered which is received directly.
- The Commissioner of Central Excise, Trichy and CC(P)'s office are requested to forward such applications along with vigilance status of the officers, as per Admn. Order dated 01/2015 dated 03/07/2015, within the stipulated date.
