## OFFFICE MEMORANDUM

Brulie Subject:

Filling up of the post of Junior Analyst (Anti Smuggling) in the Department of Revenue on deputation basis - Reg.

Eny open

It is proposed to prepare a panel of suitable officers for filling up of the post of Junior Analyst (AS) in the Department of Revenue, on usual deputation terms & conditions. The post of Junior Analyst (Anti Smuggling) is in Pay Band-3 of Rs. 9,300-34,800/- + Grade pay of Rs. 4800/- (Revised) plus usual allowances. The person selected for this post shall have the option to either draw the scale of the post of Junior Analyst (AS) or his grade pay in the parent office plus Deputation (Duty) Allowances as per the existing instructions of the Department of Personnel & Training. The period of deputation is three years.

2. The officers of the Central Government with following qualifications/ experience are eligible to apply for the post of Junior Analyst(AS), who:-

(i) are holding analogous posts; or

- (ii) have two years' service in the grade rendered after appointment thereto on a regular basis in the Grade Pay of Rs. 4600/- (Pay Band -2 of Rs. 9,300-34800/-); or
- (iii) have six years's service in the grade rendered after appointment thereto on regular basis in the Grade Pay of Rs. 4,200 (Pay Band 2 of Rs. 9300-34800/-); and
- (iv) possess experience in one or more of the following items according to the requirement of the post (to be indicated at the time of each recruitment);
  - (a) experience in Customs & Central Excise appraisement and assessment:
  - (b) familiarity with the Central Excise procedures and control over exciseable duties;
  - (c) experience in statistics and research work;
  - (d) experience of work in the field of Narcotics Department
- 3. All the Ministries/Departments of the Govt. of India are requested to forward the applications of the eligible officers, who could be spared in the event of their selection, in the enclosed pro-forma to this Department along with the following documents/ certificates within 60(sixty days) of publication of this vacancy circular:-
  - (a) Up-to-date CR Dossiers containing last five year' ACRs or photocopies of the ACR duly attested by a Class-I officer;
  - (b) Cadre Clearance;
  - (c) Integrity Certificate;
  - (d) Vigilance clearance; and
- (e) A certificate to the effect that no major/minor penalty has been imposed upon the candidate during the last 10 years.
