- 5. The willingness of the officers as per the proforma enclosed, should reach this office on or before 29/02/2016 and no application vill be entertained after that date. Willingness once exercised is final and officers are not allowed to with Iraw their applications at a later date and if so, the officer will be debarred from applying for Airport panel posting for next 3 years. The Commissioner of Central Excise, Trichy and CC (P)'s office are requested to forward such applications along with vigilance status of the officers on that date as per Note order dated 30/03/2005, within the stipulated time.
