CIRCULAR

Sub: Drawal of Panel in respect of Head Havaldar/Havaldar for posting to Customs Commissionerate tuticorin for the year 2017-18 from the cluster Commissionerate of Trichy Customs, Trichy Central Excise and CC(P)'s office, Trichy- Calling for willingness from 'Eligible Head Havaldar/Havaldar' as replacement for the long standing officers in CH Tuticorin-reg.

It is proposed to call for Written request/ Willingness as per the enclosed proforma from 'Eligible Head Havaldar/Havaldar' for panel posting as replacement for the tenure completing Head Havaldar/Havaldar in CH Tuticorin.

2. GENERAL CONDITIONS FOR ELIGIBILITY

- i) Head Havaldars/Havaldars having a minimum service of 02 years as on 30/06/2017, in the cluster Commissionerate of Trichy Customs, Trichy Central Excise and CC(P)'s office at Trichy alone are eligible.
- ii) The rotational posting to Tuticorin Customs Commissionerate will be subject to Willingness and Vigi ance clearance at the time of such posting and the Commissioner of Customs, Trichy vill be the NODAL COMMISSIONER for empanelment of the panel.
- Second posting to CH Tuticorin in the said cadres will not be considered, until all the willing officers working in cluster Commissionerate, complete their posting at Tuticorin Customs Commissionerate once in any one of the three cadres of Head Havaldar/Havaldar erstwhile Sepoy. Empanelment for second time posting will be finalized in the order of date of relief from Tuticorin Customs Commissionerate irrespective of their seniority and officers only after completion of cooloing-off period of 03 years.
- iv) The Head Havaldar/Havaldar, who had already worked in Airport/ Trichy/Karaikal port/ ICDS/ DRI or any other deputation posts, shall be eligible for Tuticorin Customs only after completion of 02 years of cooling-off period from such postings.

- 3. The selected office is from the drawn list shall be posted to CH Tuticorin for a period of 05 years and specific posting and subsequent rotation of the officers shall be carried out by Commissioner of Customs, Tuticorin. Willingness once exercised cannot be withdrawn. The officers should also note that, transfer benefits will be admissible to them only if they have completed the prescribed tenure at their present stations.
- 4. Officials, on completion of their 05 years tenure at CH Tuticorin are liable to be posted either to any formation, including the coastal formations of this Commissionerate or shall benominated to Trichy C.Ex. depending on the administrative exigencies.
- 5. Head Havaldar / Havaldar who are eligible and willing to apply for posting to CH Tuticorin as per the above conditions, may furnish their written request / willingness in the enclosed proforma with their history of postings through proper channel so as to reach this office on or before 19/04/2017.
- 6. This is issued with the approval of Commissioner of Customs, Trichy.
