Special Economic Zone as Authorised officers - Reg.

With reference to the above subject, it is stated that Nine vacancies for the post of Authorised Officer in SEZ, Chennai are likely to arise in near future and one vacancy exist for the post of Authorised officer in Cheyyar SEZ at Bargur. It has been proposed to fill up the said vacancies on willingness cum transfer basis. All Superintendents of Central Tax and Central Excise, who have not completed 56 years of age, are eligible for consideration. However, superintendents who had previously worked in SEZs as Authorised officer are not eligible for posting again in SEZ and they should not apply.

2. It is kindly requested that the same may be circulated among all the Superintendents working under your charge. The willingness of Superintendents to work in SEZ, Chennai / Cheyyar SEZ at Bargur received, if any, along with their vigilance clearance and APAR grading for the last 5 years, may be sent to this office on or before 17.07.2017 positively. All the officers who have applied for SEZ with reference to this office circular of even number dated 27.04.2017 have to apply again for consideration.
