The sealed tenders will be opened at 15:30 Hrs on 27.11.2017. Competent authority reserves the right to accept or reject any or all the quotations without assigning any reason.

ANNEXURE-A

TERMS & CONDITIONS

1. The sealed bid shall be received by this office up to 02:00 PM on 27th November 2017 along with Earnest Money Deposit by way of Demand Draft for Rs. 10000/- (Rupees Ten Thousand Only) in favour of "The Assistant Commissioner of Customs" payable at CUDDALORE. Any bid received after the prescribed deadline and are without enclosing Demand Draft for Earnest Money Deposit shall not be considered. Tender should be addressed to "The Assistant Commissioner of Customs, No-60 Mohan Singh Street Cuddalor-607 003, Tamil Nadu" and submitted in sealed cover.
2. The bids shall remain valid for a period of 2 months from the date of receipt of the bid.
3. The rates quoted by the bidders for purchase of old condemned vehicles will be all inclusive and on "As is where is basis". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the vehicles on a date and time specified by this office and will arrange for transportation of the same on that day itself at his expense.
4. The vehicles will be disposed off on the basis of highest rate. However, this office reserves the right to withdraw the vehicles from the bidding process in case the quoted price received is less than the reasonable market price.
5. The successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/time entails the forfeiture of the contract as well as Earnest Money. After delivery of the vehicles, this office will not be responsible for any damages to the vehicle or person.
6. This office reserves the right to annul the bidding process at any time prior to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office's action.
7. The bidders may physically visit and inspect the Car before putting in their bid. The Superintendent, DPU Section, No-60 Mohan Singh Street Cuddalor-607 003, Tamil Nadu may be contacted for inspection of the vehicles. **The inspection of the vehicles may be done from 10:00 AM to 05:00 PM of any working day up to 24/11/2017.** No complaint of whatsoever nature will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.
8. The vehicle shall be handed over to the successful bidder against 100% deposit of offer/bid value.
9. The payment will be accepted by this office in the form of **Demand Draft of a nationalized bank** only. The payment has to be submitted by the successful bidder within 7 days of the date of delivery of the order otherwise the offer will be cancelled and earnest money shall be forfeited.
10. Disputes, if any, shall be subject to the jurisdiction of the Court of Cuddalore only.

11. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.

12. Once the release order is issued, this office will not be responsible either for safe custody or for any loss or damage to the subject vehicle.

13. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.

14. The sealed tenders super scribed "Tender for sale of condemned office vehicle" will be opened on 27/11/2017 at 15:30 Hrs. in the presence of available bidders, if any.

15. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reasons, the same will be opened on the next immediate working day.

16. The bidders should quote the amount for purchase of the subject vehicles (separately for each) both in words and in figures. If there is any difference between the amounts mentioned in figures and that of in words, the rate quoted in words will be taken in to account and accepted on record.

17. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.

18. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any of documents as documentary evidence for proof of their address. (Ration Card/Voters Identity Card/Aadhar Card in case of individual and Registration Certificate in case of firms etc.)

19. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.

20. The highest bidder shall be required to deposit the total amount of the vehicle within 7 days and the vehicle is to be lifted at his/their own expenses immediately after completion of statutory requirements. Permission to take out the disposed vehicle from Custom Division, Cuddalore is allowed only on working days.
