Tender Bid forms along with agreement terms and conditions can be obtained from the Administrative Officer, Office of the Chief Commissioner of Customs (Preventive), No.1, Williams Road, Contonment, Tiruchirapalli, in all working days (Monday to Friday) between 11.00 A.M. to 5.00 P.M. on payment of Rs. 500/- (Non-Refundable) in Demand draft/Banker's cheque of scheduled bank drawn in favour of the AO (DDO), Office of the Chief Commissioner of Customs (Preventive), Tiruchirapalli. The completed tender in sealed cover with a remark on the cover "TENDER FOR HIRING OF VEHCILES" and the same should be submitted to the Administrative Officer, Office of the Chief Commissioner of Customs (Preventive), No.1, Williams Road, Contonment, Tiruchirapalli during the working hours either in person or through post. The last date of receipt of completed tender forms along with EMD is upto 5.00 P.M. on 05.09.2017.

Tenders may be submitted for entire requirement. Tender for partial requirement will not be entertained. Late bids will not be entertained. Incomplete bids will be summarily rejected. No bids will be permitted to alter after deadline for receipt of bids.

The tenders will be opened on 06.09.2017 at 4.00 P.M. by Committee of Officers nominated by the Department, in presence of tenderer or authorised representatives of the tenderers.

Terms and conditions for Bidding

- 1. This hiring vehicles contract will be valid from date of issue of order to 31.03.2018 which may be extended for further period of one year with the same terms and conditions and for a maximum period of 3 years.
- 2. The vehicle should be parked in the office campus at Office of the Chief Commissioner of Customs (Preventive), No.1, Williams Road, Contonment, Tiruchirapall and using the vehicle for 24X7 days. The driver should be available on call of the officer for 24X7 days.
- 3. The Bidder should have to deposit Bid Security (EMD) of about Rs. 10,000/- in any one of the following forms;
 - (i) Account Payee Demand Draft
 - (ii) Fixed deposit receipt from a Commercial Bank
 - (iii) Bank Guarantee from a Commercial Bank in acceptable form.
- 4. All the above should be drawn in favour of AO (DDO), Office of the Chief Commissioner of Customs (Preventive), Tiruchirapalli.
- 5. Bid security should be valid for a period of 30 days from the date of tender and the same will be returned after completion of entering the contract.
- 6. Only those bids which fulfil the technical conditions will qualify for the financial bidding.
- 7. The bid security will be forfeited in case the information provided by the bidder is false, bidder withdraws the bid during the period of bid validity, if he fails to entering contract or fails to furnish performance security.
- 8. No interest will be payable of bid security or performance security when the same is returned.
- 9. The successful bidder / the vendor to who the contract is awarded should have to deposit a performance security amount of 5% of the value of the contract (as per the Rule 158 of GFR, 2005). Such performance security will be returned after 30 days from the date of completion of the contract.
