Sub: Establishment – Recruitment - Filling up of Posts in Marine Crew Group 'C' Cadres in the Grade of **SEAMAN** for Customs (Preventive) Commissionerate, Tiruchirappalli –Offer of Appointment- Regarding.

Ref: (i) This office Recruitment Notification C.No.II/31/07/2016-Estt (Cus) dated 26.10.2017; (ii) Call Letters dated 13.02.2018 & dated 08.03.2018.

With respect to the references mentioned above, on completion of the process of selection, the following candidates are hereby offered appointment to the post of **SEAMAN**, Group "C" Cadre of Marine Wing in the Customs (Preventive) Commissionerate, Tiruchirappalli in the Entry Pay of Rs.18000/- (Index 1, Level 1 of Pay Matrix of 7th Pay Commission) plus other allowances as admissible :

This offer of appointment is subject to the conditions given here under:-

- 2.1 His services are liable to be terminated on giving one month's notice from either side in accordance with the Central Civil Services (Temporary Service) Rules, 1965, without assigning any reasons. The Appointing Authority, however, reserves the right of terminating their services forthwith or before the expiration of the stipulated period of notice by making payment to them of a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- 2.2 He shall be on probation for a minimum period of two years from the date of initial joining in the post to which appointed, the period of which may be extended at the discretion of the Competent Authority. On completion of the probation period satisfactorily, he will be considered for confirmation in the post offered.
- 2.3 The candidate shall equip himself with prescribed uniform and shall be subject to usual discipline which is expected of those in uniform. He shall not indulge in activities not officially organized or in any manner which would be considered as indiscipline in service.
- 2.4 The seniority of the candidate in the grade of Seaman shall be fixed as per the orders in force.
- 2.5 With regard to Leave, travelling allowance and all other matters connected with service conditions, he shall be governed by the rules and orders in force from time to time and applicable to the branch of public service to which he may belong.
- 2.6 He shall be liable to be posted and transferred anywhere within the Cadre Control jurisdiction of Marine Wing of the Commissioner of Customs (Preventive), Tiruchirappalli and under no circumstances, request of candidate for transfer to any other Commissionerate/ place shall be entertained.
- 2.7 He shall not be entitled to travelling allowance for joining the post.

2.8 For appointment to posts under the Central Government on the result of a competitive examination/ or interview open to Government servants and others, Central Government employees and permanent/ provisionally permanent State Government employees will be entitled to joining time under the relevant rules. But temporary employees of Central Government who have not completed 3 years of regular continuous service entitled to joining time would not be entitled to joining time pay.

2.9 He has to give the following undertaking before taking up the appointment:

“I understand that my appointment under Government is provisional and that my service may be terminated at any time by a month notice on either side without assigning any reason that the appointing authority reserves the right of termination of my service forthwith or before the expiry of stipulated period of notice by making payment to me of a sum equivalent of notice to the pay and allowances for the period of the notice or the unexpired portion thereof”.

2.10 On joining the post, he shall be required to take an oath of allegiance to the Constitution of India or have to make a solemn affirmation to that effect in the following form:

“ I,, do swear / solemnly affirm that I will be faithful and bear true allegiance to India and to the Constitution of India as by law established, that I will uphold the sovereignty and Integrity of India, and that I will carry out the duties of my office loyally, honestly and with impartiality. “SO HELP ME GOD”.

2.11 If he is already employed, he should produce a relieving order from the previous employer.

2.12 In accordance with the relevant rules in force in regard to the recruitment to services under the Government of India,

(a) No person who has more than one wife living or who, having a spouse living, contracts to a second marriage, though such marriage is void by reason of its taking place during the life-time of such spouse, shall be eligible for appointment to service, provided that the Central Government may, if satisfied that there are special grounds for so ordering, exempt any person from the operation of this rule.

(b) No such woman whose marriage is void by reason of its taking place during the life-time of her spouse or who have married to such a person whose wife is living at the time of marriage shall be eligible for appointment in service unless the Government of India has granted exemption to such a woman in accordance with this rule after being satisfied that there are special grounds for so ordering.

(c) This offer of appointment is, therefore, conditional upon his satisfying the requirement mentioned and furnishing declaration in the form enclosed to this letter, along with his reply. If, however, he does not fulfil the above condition and he desires to be exempted from the above mentioned rules for any reason, he should make a representation in

this behalf immediately. This offer of appointment should, in that case, be treated as cancelled and a further communication shall be sent to him in due course, if upon consideration of his representation, it is decided to offer him appointment to the post of Seaman in this Department.

(d) If any declaration given or information furnished by him is proved to be false or if he is found to have wilfully suppressed any marital information, he shall be liable for removal from service and other action as Government may deem necessary.

2.13 The candidate should produce **Attestation Form (in duplicate) (both in original) (in the format enclosed)** at the time of joining.

2.14 The candidate has to undergo Physical Fitness test from the Government Civil Surgeon, Trichy for which a letter will be issued from this Office at the time of joining and after completion of the Physical fitness test, the original Medical Certificate of Physical Fitness should be produced in this office.

2.15 **This offer of appointment is purely temporary and is subject to receipt of the antecedent verification report from the concerned District/Police Authorities. In case any adverse/negative report is received from the concerned District/Police Authorities, the appointment / services will be terminated immediately without assigning any reason or notice.**

3. If the above conditions are accepted, the candidate may report for duty before the undersigned in the Office of the Commissioner of Customs, No.1, Williams Road, Cantonment, Tiruchirappalli-620001 **on or before 30.05.2018 with the following documents (IN ORIGINAL) and the copies of the same:**

- (i) Attested copies of Education Qualifications;
- (ii) Attested copies of Certificate of Age;
- (iii) Caste Certificate in case of SC/ST/OBC;
- (iv) Relief Order / NOC from the present employer (if applicable)
- (v) Proof of certificates for sea service

Failing which this offer of appointment will stand automatically cancelled.

4. If the candidate claims to belong to a Scheduled Caste, Scheduled Tribe or Other backward Classes, he has to produce a certificate issued in the prescribed format (as prescribed in M.H.A. O.M. No. 42/21/49-N.G.S, dated 28.01.1952 as amended /DOPT O.M. No. 36033/28/94-Estt.(Res) dated 02.07.1997 as applicable by any of the Judicial / Revenue Authorities mentioned therein. He should note that his appointment will be provisional and subject to verification of the Caste / Tribe Certificate through proper channels and that if the claim to belong to SC/ST/OBC or not to belong to creamy layer is found to be false, his service will be terminated forthwith without assigning any reason and without prejudice to such further action that may be taken under the Indian Penal Code for production of false


certificate. He should also intimate the change, if any, of their religion, after appointment, immediately to the Appointing / Administrative Authorities concerned.

5. The candidate may also note that he shall be governed by the New Pension Scheme as notified vide Government of India, Ministry of Finance, Notification No.5/7/2003-EECB & PR dated 22.12.2003 - published in Government of India, Extraordinary, Part I – Section 1, dated 22.12.2003. However, this will not apply to a permanent Government Servant who joins the post on tendering technical resignation under Rules 26(2) of CCS (Pension) Rules, 1972 on reappointment to the post.

6. This issues with the approval of the Competent Authority.
