Sub: Calling of willingness from Superintendent to serve in
Special Economic Zone as Authorised officers – Reg.

With reference to the above subject, it is stated that there exist six vacancies for the post of Authorised officers in SEZs located at Chennai. Further, two more vacancies in SEZs located at Chennai and one vacancy each in SEZs located at Tuticorin and Gaingaikondan are likely to arise in near future. It has been proposed to fill up the said vacancies on transfer basis based on Willingness/Seniority/APAR gradings/Vigilance status. All Superintendents of Central Tax, who have not completed 56 years of age, are eligible for consideration. However, superintendents who had previously worked in SEZs as Authorised officers are not eligible for posting again in SEZ and they should not apply.

2. It is kindly requested that the same may be circulated among all the Superintendents working under your charge (including officers working on loan basis in various Directorates). The willingness of the Superintendents to work in the above mentioned SEZs received, if any, along with their vigilance clearance and APAR gradings for the last 5 years, may be sent to this office on or before 15.02.2018 positively.
