**CIRCULAR**

Sub : Drawal of panel of eligible Superintendent/Inspectors for panel posting to Customs Airport Trichy for the year 2018-19 - Reg.

Ref : CC(P)'s Administrative Order No.02/2017 dt. 10/11/2017 & further Addendum issued dated 22/11/2017 by the Chief Commissioner of Customs (Prev.), Trichy.

It is proposed to draw a panel for posting of Superintendents (excluding Air Cargo) & Inspectors to Customs Airport Trichy for the year 2018-19 as per Administrative Order No.02/2017 & Addendum referred above (Copy hosted on Customs, Trichy website for reference).

2 The minimum eligibility conditions for officers to express willingness for the above panel posting have been fixed as follows:

**Superintendents & Inspectors**

Qualifying Service in the cluster Commissionerate (para 4.02) & on ICT (para 4.03)	2 Years
Cooling-off period after Deputation like DRI, NCB, DGCEI/NCB, etc,(para 4.04)	2 Years
Cooling-off period after repatriation from CH Tuticorin (para 9.01)	2 Years
ICDs at Pondy/Arakkonam/Karur	
CH Pondy/Karaikal Port, CFS under Trichy Customs (P) (para 9.03)	Waived

3. The eligibility cut-off date for drawal of the panel is fixed as **30/06/2018**. The Panel would be drawn from the officers satisfying the above conditions and on their Seniority cum Vigilance clearance cum suitability adjudged by the competent authority.

4. The willingness of the officers as per the proforma enclosed (duly attested by the concerned AO) should reach this office **on or before 22/02/2018** and no application will be entertained after that date. Willingness once exercised is final and officers will not be eligible for the panel posting to Airport, Trichy for the next 03 years.

5. The Commissioner of GST & Central Excise, Trichy and CC (P)'s office are requested to forward such applications along with certification that all the officers are free from vigilance angle as on that date and suitable as per their past records for sensitive postings, within the stipulated time. Similarly vigilance clearance is required at the time of posting to Airport.

6. This is issued with the approval of Commissioner of Customs (P), Trichy.

I am aware that -

- (a) on completion of panel posting at Customs Airport, Trichy, I am liable for posting to any of the coastal formations under Trichy Customs (P) Commissionerate and will be required to serve a minimum period of 2/3/4 years , as the case may be in such formations and that the condition of serving n coastal formation is compulsory.
- (b) Requests for ICT to other zones during Airport Tenure will not be forwarded to Cadre controlling Authority. Similarly ICT to other zones during service at coastal formation without completion of tenure would not be sent to CCA.
- (c) Relief on ICT to other zones on completion of Airport posting, will not be considered without completion of minimum service in coastal formations
- (d) Request for transfer to Trichy GST & C.Ex. or any other GST & C.Ex. Commissionerate will not be ordinarily entertained. Deputation requests shall be entertained only after one year of completion of panel posting
- (e) In case of those seeking deputation while in panel posting, the following two guidelines shall be adopted:-
  - (i) Officers, who have completed less than 50% of the panel tenure, can apply for deputation.
  - (ii) For others, they can seek repatriation from panel tenure and apply for deputation after **one year from the date of repatriation.**
