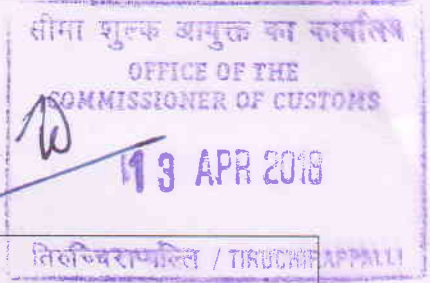

SUBJECT: - Filling up of existing 25% Quota vacancies allotted to Customs Commissionerate under Airpool Policy for posting at Indira Gandhi International Airport, New Delhi-reg.

Your kind attention is invited towards the Board Circular issued vide F.NO. A-11019/102/91-Ad.IV dated 21.10.1993 and Board Circular issued under F.No. A-11019/22/2007-Ad.IV dated 22.12.2008. In terms of the Airpool Policy framed vide aforesaid Board Circulars, 25% of the sanctioned strength in the grade of Air Customs Superintendent (ACS) and Air Customs Officer (ACO) at Indira Gandhi International Airport, New Delhi, are to be filled from other Customs Houses.

2. As per Para 2 (ii) read with Annexure-11 of the Board Circular issued vide F.NO. A-11019/102/91-Ad.IV dated 21.10.1993, posting at IGI Airport in the grade of ACS and ACO at IGI Airport, is prescribed from the following Custom Houses:-

- (i) Mumbai, Goa, Nhava Sheva.
- (ii) Calcutta (Kolkata)
- (iii) Cochin
- (iv) Madras Vizag

3. In terms of Para 3(ii) of the Board Circular issued under F.No. A-11019/22/2007-Ad.IV dated 22.12.2008, it is stipulated that:

“(ii) In cases where 25% quota of ACS / ACOs from the specified outside Customs or Central Excise Commissionerates is not getting filled up, the same shall extended to all Commissionerate of that category i.e. if the outside quota is for specified Customs Commissionerates, it shall be extended to all the outside Customs Commissionerates and if the outside quota is for specified Central

Excise Commissionerates, the same shall be extended to all Central Excise Commissionerates.

4. As per aforesaid Airpool Policy, 25% outside quota at IGI Airport, New Delhi, are allotted to various Customs Commissionerate mentioned above. At present, the vacancy position under 25% quota at IGI Airport, New Delhi, is as under:-

5. On account of the existing vacancies under 25% outside quota at IGI Airport, it is proposed to fill the said vacancies, in terms of Board Circular issued vide F.NO. A-11019/102/91-Ad.IV dated 21.10.1993 and Board Circular issued under F.No. A-11019/22/2007-Ad.IV dated 22.12.2008, from the officers in the grade of Superintendent and Inspectors working in different Custom Houses.

6. In view of above, it is requested to forward the willingness of officers in the grade of Superintendent of Customs and Preventive officers posted under your charge alongwith following documents:-

- a) Willingness Application
- b) Bio Data.
- c) History of Posting.
- d) APAR Grading for last 5 years.
- e) Vigilance Clearance Certificate.
- f) Integrity Certificate
- g) No Objection Certificate regarding relieving of Officer in case he / she is selected for ACS / ACO at IGI Airport.
