Kind attention of the Importers, Exporters, Customs Brokers, Custodians, Trade and other stakeholders is invited to the Notification No.77/2014 – Customs (N.T), 78/2014 – Customs (N.T.) both dated 16.09.2014 and Notification No. 82/2017 – Customs (N.T), dated 24.08.2017 and Notification No. 85/2017-Customs (N.T.) dated 07.09.2017 as amended vide 86/2017-Customs (N.T.) dated 14.09.2017, 92/2017-Customs (N.T.) dated 28.09.2017, 99/2017-Customs (N.T.) dated 27.10.2017, 119/2017-Customs (N.T.) dated 28.12.2017 issued and as amended vide 03/2018-Customs(N.T) dated 10.01.2018 by the Central Board of Excise and Customs, Department of Revenue, Ministry of Finance, on the above subject.
