Public Notice No. 22018 (Amendment to the Notification No. 02/2004 dated 26.07.2004)

Sub:- Permission for handling of LCL Export Cargo at ICD, Karur-reg

Attention of all the Steamer Agent, Exporters, Importers and their Representatives (Custom Brokers) is invited to this office Notification No. 02/2004 dated 26.07.2004 issued under Section 8(a)of the Customs Act,1962 declaring ICD of M/Kerry Indev Logistics Private Limited (erstwhile M/s Continental Container Freight Station/Indev Logistics Private Limited) at Karur in the state of Tamilnadu as the Customs area for the purpose of handling of Import and Export cargo.

2. At the request of M/s Kerry Indev Logistics Private Limited and in exercise of power conferred under Section 8(b) of the Customs Act, 1962, out of the total existing covered warehouse area measuring 9000 sq Ft , an area measuring 1500 sq.ft is demarcated for the purpose of LCL operation(consolidation of Export Cargo). Consequently, the total warehouse area is as reallocated and amended as follows-

LCL(Export) Warehouse- 1500 Sq. ft FCL(Export) Warehouse- 6700 Sq. ft FCL(Import) Warehouse-800 Sq.ft

3. M/s Kerry Indev Logistics, the Custodian, are hereby informed that

- i. They should demarcate the area for LCL and FCL Cargo and the Export LCL Cargo should be kept in the area allotted for the said purpose and should not be mixed with other FCL cargo.
- ii. The shed should be provided with the lock facility for storage of sensitive cargo;
- iii. They should ensure that no hardship is caused to the Importer/Exporter.
- iv. The procedure outlined in Board's Circular 55/2000 dated 30.06.2000 for the operation of Hub-point operation (consolidation of Export Cargo), the provisions of Handling of Cargo in Customs Area Regulation (HCCAR), 2009 and the relevant provisions of Customs Act, 1962 have to be followed by the custodian.
- v. The Public Notice will come in effect from the date of issue.
