Examination (written and oral examinations) under Regulation 13(5) of
CBLR, 2018 for the year 2019 - Reg.

The examination for grant of Form “G” card under Regulation 13(5) of Customs Broker
Licensing Regulation, 2018 for the year 2019 will be held as per the following schedule:

Last date for Receipt of completed Application Forms	28.02.2019(Thursday up to 17.00 Hours
Date of issue of Admission Cards	14.03.2019 (Thursday)
Date and Venue of written examination	04.04.2019(Thursday) venue will be intimated later

1. ELIGIBILITY:

Employees of the Customs Brokers having valid “H” card who have passed at least 10+2 or equivalent may apply for the “G” Card Examination.

2. DETAILS OF THE EXAMINATION:

2.1 The examination, tests the candidate’s knowledge of Customs Act and procedures related to clearance of goods and baggage through Customs. The examination will be of two parts:

Type of examination	Duration	Max. Marks	Qualifying Marks
Written Examination (Both objective and subjective)	3 hours	100	50
Oral examination		100	50

2.2 Each applicant may avail a maximum of four chances/attempts from the first appearance of the Written Examination

2.3 If a person qualifies in the Written examination but does not qualify in the Oral Examination, he/she can use his /her remaining chances to appear directly in the subsequent oral examinations i.e. , he/she need not appear in the Written examination again. If a person applies for the Form G examination but does not appear in the Written Examination, it will not be counted as an attempt. If a person qualifies in the written examination only in his /her fourth attempt, he /she will get if a only chance for the Oral examination linked to that written examination.

2.4 The candidates should report at 9.00Am at the Venue of Examination mentioned in the admit card with the original form "H" ID card and Admit Card.

3. HOW TO APPLY

3.1 Employees, partners and Directors of the Customs Brokers having valid "H" card who have passed atleast 10+2 or equivalent may apply for the Form "G" Examination.

3.2 The application of the candidate should have:

- (a) Annexure -I filled and signed by the candidate
- (b) passport size photograph pasted on Annexure -I, signed by the candidate
- (c) Annexure -II in duplicate filled by the candidate with a recent passport size photograph pasted. The candidate should sign both on the annexure and on the photograph.
- (d) Attested copy of 'H' card(both sides)
- (e) Attested copy of certificate/mark sheet of qualification(minimum 10+2 or equivalent)
- (f) TR-6 Challan for Rs. 300/- as evidencing payment of examination fee

4. EXAMINATION FEE

4.1 The candidate shall pay an examination fee of Rs. 300/- through TR-6 Challan in authorised banks

4.2 Fee once paid shall not be refunded or tranfered or adjusted against any future examination, under any circumstances.

5. INVALID APPLICATION

5.1 Application not complying with conditions stated in Para 3 of above (or) incomplete or which are received after the last date will be summarily rejected without making any correspondence in this regard. Also no further correspondene will be entertained in this regard.

5.2 In case, declarations and information submitted by the applicant are found to be incorrect, the application shall be rejected or the connected G-card issued if any will be cancelled.

5.3 In all cases the decision of the Principal Commissioner of Customs (Preventive), Trichy regarding validity of application shall be final.

6. MOBILE PHONES BANNED:

6.1 Mobile phones, pagers or any other Electronic (or) Communication devices are not allowed inside the examination Hall. Any infringement of these instruction shall entail disciplinary action including ban to write future examinations.

6.2 Candidates are advised in their own interest not to bring any of the banned items including mobile phones/pagers or any valuable / costly items to the venue of the examination, since safe keeping of the personal belongings cannot be assured. This office will not be responsible for any loss in this regard.
