**Last date for submission of tender is 05.12.2019 up to 05:00 PM. The sealed tenders will be opened on 06.12.2019 at 11:00 A.M in the presence of bidders.**



ANNEXURE-A

TERMS & CONDITIONS

1. The sealed bid shall be **received by this office up to 5:00 PM on 05.12.2019**. Any bid received after the prescribed deadline shall not be considered. Tender should be addressed to "The Assistant Commissioner of Customs, Customs Division, Nagapattinam".
2. The bid to be quoted should be a consolidated quote for all confiscated goods. Separate quote for individual confiscated goods will not be considered.
3. The bids shall remain valid for a period of 2 months from the date of receipt of the bid.
4. The rates quoted by the bidders for purchase of old confiscated goods will be all inclusive and on "As is where is basis". Any statutory or other charges shall be borne by the bidder. The successful bidder will take possession of the goods on a date and time specified by this office and will arrange for transportation of the same on that day at his expense.
5. The goods will be disposed off on the basis of highest rate. However, this office reserves the right to withdraw the goods from the bidding process in case the quoted price received is less than the reasonable market price.
6. The successful bidder must adhere to the time limit. Failure to deposit the requisite sum before the stipulated date/ time entails the forfeiture of the contract as well as Earnest Money. After delivery of the goods, this office will not be responsible for any damages to the goods or person
7. This office reserves the right to annul the bidding process at any time prior to award of contract including rejection of any or all bids after the same have been received, without thereby incurring any liability to the affected bidder/s or any obligation to inform the affected bidders on the ground of this office's action.
8. The bidders may physically visit and inspect the goods before putting in their bid. The Superintendent, Preventive Unit, Custom Division Nagapattinam may be contacted for inspection of the goods. **The inspection of the goods may be done from 10:00 AM to 05:00 PM of any working day up to 04.12.2019**. No complaint whatsoever will be entertained after closing of tender. No request for inspection after submission of tender will be accepted.
9. The goods shall be handed over to the successful bidder against 100% deposit of offer/ bid value.
10. The payment will be accepted by this office in the form of **Demand Draft of a nationalized bank** only. The payment has to be submitted by the successful bidder within 7 days of the date of delivery of the order otherwise the offer will be cancelled and earnest money shall be forfeited.
11. Disputes, if any, shall be subject to jurisdiction in the Court of Nagapattinam only.
12. Tendering form should be signed in ink by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
13. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the subject goods.

14. In case the bidder is a company, the name of the company should be indicated as the bidder. In such cases the person appearing for the company should have the authorization letter in a proper format issued from a competent authority of the company. Request to change the name of the bidder in the tender after submission of the tender will not be entertained.
15. The sealed tenders super scribed "**Tender for sale of Confiscated Goods**" will be opened **on 06.12.2019 at 11:00 A.M** in presence of bidders, if any.
16. The scheduled day for opening the sealed tenders, if declared to be holiday due to any unforeseen reasons, the same will be opened the next immediate working day.
17. The bidders should quote the amount for purchase of the subject goods both in words and in figures, if there is any difference between the amounts mentioned in figures and that of in words, the rate quoted in words will be taken in to account and accepted on record.
18. The bidder is required to reveal his full name/name of the authorized signatory of the firm/name of father, full postal address, telephone number & mobile number.
19. The person authorized by bidder will be allowed to take the delivery. The bidder is required to produce any of documents as documentary evidence for proof of their address. (Ration Card /Voters Identity Card in case of individual and Registration Certificate in case of firms etc.)
20. The goods will be delivered only after the receipt of full payment and has to be lifted at their own expenses within 07 days of completion of deal. Permission to take out the disposed goods from above mentioned locations will not be allowed on holidays, Saturdays and Sundays etc.
