Sub: Difficulties faced by the exporters (including rice and others) for claiming the RoDTEP benefit consequent to alignment of customs tariff w.e.f. 01.05.2025 – Reg.

Attention of officers is directed to Public Notice No. 21/2025 dated 13.08.2025 on the above subject (copy enclosed).

2. As narrated in the said notice, RoDTEP benefits allowed retrospectively on certain tariff items through DGFT notifications have been allowed by Central Board of Indirect Taxes & Customs (CBIC) / Board by way of amendment in the Shipping Bills through Post EGM amendment module of ICES.

3. Officers may be aware that DG (Systems) had issued following advisories with respect to such amendments in post EGM amendment module of ICES

—

(i) Advisory No. 16 dated 25.03.2025

(ii) Advisory No. 18 dated 07.04.2025

4. Accordingly, for the Shipping Bills filed on or after 01.05.2025, requests made by exporters for amendment to Shipping Bills to allow claim of RoDTEP for tariff items mentioned in DGFT Notification No. 10/2025-26 and 11/2025-26 both dated 26.05.2025 shall be processed using Post EGM amendment module of ICES by amending RoDTEP claimed from “N” to “Y”.

5. Needless to say, such amendment when sought may be processed expeditiously. Difficulties, if any faced may be brought to the notice of EDI Section without fail.
