Sub.: Implementation of automation in the Customs (Import of Goods at Concessional Rate of Duty or for Specified End Use) Rules, 2022- Reg.

Attention of trade and general public is invited to the above subject. Trade may be aware that vide Circular No.04/2022-Customs dated 27.02.2022, CBIC/Board clarified regarding amendments made in IGCR Rules, 2017. In this regard, Circular No.25/2024-Customs dated 21.11.2024 has been issued by CBIC /Board. The operative portion of the said Circular is appended below:

Circular No.25/2024-Customs dated 21.11.2024

3. Considering the request of stakeholders, Board has decided to permit the importers who are facing difficulties on electronic filing of their IGCR-3 monthly statement, may do so **manually before jurisdictional officers till 31.01.2025**. The monthly statement is to be filed online from the month of February 2025.

4. Further, an excel utility is being made available by DG Systems, CBIC by 15th December 2024 for filing IGCR-3 monthly statement. The importers are encouraged to make use of the same to file their IGCR3/IGCR 3A statements electronically for present and past periods. The same may be completed latest by 31st January 2025.

Trade and General Public may take note of the above circular regarding online filing of returns IGCR 3/IGCR 3A. **Officers may ensure filing of back log returns before the time stipulated.** Difficulties, if any, faced, may be brought to the notice of this office.
