Sub.: Extension of RoDTEP Scheme for exports made from DTA Units and AA/EOU/SEZ Units - Regd.

Attention of trade, exporters and general public is invited to the above subject. In this regard, trade may be aware that vide Notification No. 32/2024-25 New Delhi dated 30.09.2024, Directorate General of Foreign Trade (DGFT) has provided extension of the RoDTEP Scheme as follows -

- i. The RoDTEP Scheme is extended for exports made from DTA Units till 30.09.2025
 - ii. The said Scheme for AA/EOU/SEZ Units is extended till 31.12.2024.
2. In this regard, it has been ascertained from ICEGATE and DGFT websites that the RoDTEP Scheme for SEZ/EOU/AA (ii above) has been extended till 29.01.2025 as an interim measure to facilitate trade. Trade and General Public may take note of the further extensions given so that benefits of the Scheme may be availed.
 3. Difficulties, if any, may be brought to the notice of this office.
