PUBLIC NOTICE NO. 21/2025

Sub: Difficulty faced by the exporters (including rice and others) for claiming the RoDTEP benefit consequent to alignment of customs tariff w.e.f. 01.05.2025 – Reg.

Attention of Trade and General Public is invited to above subject.

- 2. Trade may be aware that DGFT Notified RoDTEP benefits for some tariff items with retrospective effect (w.e.f. 01.05.2025) for various stake holders / exporters vide Notification No. 10/2025-26 and 11/2025-26 both dated 26.05.2025. As these notifications had retrospective effect, the RoDTEP rates could not have been claimed by exporters prior to implementation of the said notification in Custom Automated System (CAS).
- 3. Central Board of Indirect Taxes & Customs (CBIC) / Board had issued letter F.No. 602/4/2025/853-885 dated 14.07.2025 to allow claim of RoDTEP on the tariff items mentioned in the said DGFT notifications by way of amendment of S/Bs in post EGM amendment module of ICES. So, eligible exporters, if they so wish, may seek such amendments in S/B, in post EGM module.
- 4. Customs officers would process such requests through post EGM amendment module in ICES by amending the Shipping Bills following the system advisories issued in this respect. Standing instructions are being issued to customs officers in this regard to

process such requests expeditiously.

5. Exporters who wish to make such RoDTEP claims may therefore seek Shipping Bill amendment in post EGM module with the jurisdictional Customs authorities. Difficulties, if any, faced may please be brought to notice.
