NOTIFICATION No.01/2012

(ISSUED UNDER SECTION 8 OF THE CUSTOMS ACT)

Sub: Declaration of Container Freight Station set up by M/s. Western Gateway Cargo Services Pvt. Ltd. 76d, MC Road, Govindapuram village, Ambur, as Customs area under Section 8(b) of Customs Act 1962 for handling both import and export cargo – Reg.

In exercise of the powers conferred under section 8(b) of the Customs Act 1962, the premises of Container Freight Station situated at No.76d, MC Road, Govindapuram village, Ambur, Vellore Dist., set up by M/s. Western Gateway Cargo Services Pvt. Ltd., Ambur with the approval of Ministry of Commerce vide letter No.16/25/2011-Infra-1 Dated; 02.02.2012 is notified as 'CUSTOMS AREA' by Commissioner of Customs, Trichy vide Notification No.1/2012 dated;15.11.2012 for the purpose of unloading, destuffing and customs examination of full container load(FCL) containing imported goods and also for the purpose of Customs examination and loading/stuffing of export cargo into containers under Customs supervision and sealing of the same by Customs with Customs seal.

DESCRIPTION OF THE AREA AND LOCATION OF PREMISES:

2. The CFS premises having an area of 5.91 Acres of land taken on lease by M/s. Western Gateway Cargo Services Pvt. Ltd., Ambur situated at No.76d, MC Road, Govindapuram village, Ambur, Vellore Dist., with boundaries on four sides as noted below:-

East by: Chennai – Bangalore High Way Road
West by: T. S. No. 1/4F & T. S. No. 1/4G Lands
North by: T. S. No. 4/2B
South by: T. S. No. 2/4 & 2/5.

3. I further specify the following Customs area for the storage of imported / Export goods.
The CFS have covered warehouse area 9,795 sq. ft.(Export – 4,895 sq. ft. and Import – 4,900 sq. ft.), open paved concreated yard of 50,000 Sq.ft for containers trailer parking and 900 sq.ft for office building.
