Sub:- Re-organization of Customs preventive formations in Trichy Customs Commissionerate w.e.f. 01.03.2005 - Certain Instructions - Reg.

Ref:- Chief Commissioner of Customs (Prev), Chennai Administrative Order No.1/2005 dated 24.02.2005.

1.01 Chief Commissioner of Customs (Prev.) Chennai Administrative Order No.01/2005 [issued from file C.No.II/39/30/2004-CC(P)] dated.24.02.2005, reorganizing the Coastal & Land jurisdiction of 5 Customs Divisions and 20 Customs Preventive Units and 3 Customs Sea Base Units and Distributing Sanctioned Strength of Commissionerate Hqrs. and 05 Customs Divisional Offices and field formations of Trichy Customs Commissionerate with effect from 01.03.2005 are enclosed.

1.02 Consequent on the reorganization of formations in Trichy Customs Commissionerate, the CC (Prev) Chennai, has ordered that the following 09 Customs Preventive Field formations are to be tagged on to the nearest CPU / CSBU housed in Govt. building / Spacious rented building with effect from 01.03.2005.

2.01 The following instructions are issued in connection with reorganization of formations for immediate compliance.

2.02 The Superintendents in-charge of the concerned formations are required to make detailed inventory of the following items in triplicate and then handover and take-over after due endorsement by both Superintendents in all copies as per Annexure-I.


1. Files, Registers and Records
2. Furniture / Office equipments / Cycle
3. Anti-smuggling equipments
4. Arms & Ammunitions
5. Telecommunication equipments with accessories

2.03. Vessels / OB Motors have to be inventoried in triplicate and then transferred as per Annexure II.

2.04. Motor Vehicles (Four Wheelers) / Motor bikes of the tagged on formations are to be transferred to the formations as per Annexure III. The Superintendent receiving the vehicle should ensure that the vehicle is received along with R.C.Book/ Road Tax paid token along with log book ( Part I. and Part II), etc.

- 2.05. One copy each of the inventory showing the list of files / records; anti smuggling equipments; Motor vehicles / vessels and accessories; shall be kept with the Supdt. Handing over the charge and one copy for the Supdt. Taking over the charge and one copy should be forwarded to the jurisdictional Divl. AC / DC for records.
- 2.06 Officers should exercise extra caution / care while handing over and receiving of Arms & Ammunitions.
3. The Superintendent in-charge of concerned formations which are presently housed in rented buildings, are required to immediately issue prior notice to the land lord for terminating the lease w.e.f.01.04.2005. Notice is to be given only where there is a valid lease agreement executed and accepted till 01.04.2005 otherwise oral intimation will be sufficient. The present building can be kept till 31.03.2005, so as to enable the officers to shift the office equipments.
4. Building Rent / Electricity charges are to be paid upto 31.03.2005. Necessary intimation may be given to the EB Office regarding vacation of office buildings.
5. Telephone connection in respect of the 09 formations should be surrendered on or before 31.03.2005.
6. Postal authorities may be intimated suitably to redirect all the posts to the concerned re-vamped formations.
7. A List containing arrears of penalty should be prepared by the Superintendents of the tagged on formation and sent to the Divisional Office – Technical Section. The Divisional DC/AC shall distribute the cases of arrears of penalty to the formation having jurisdiction over the address where the defaulters reside.
8. Entries should be immediately made in the 335-C register in respect of the revamped jurisdiction with the authority no. and date.
9. Seized goods, if any kept in the concerned formations, should be immediately handed over to the Divisional Seized goods Godown.
10. If any case file is pending submission for adjudication in the concerned formation, it should be processed immediately and submitted for adjudication.
11. The officers in-charge of the field formation are required to re-write the Name board, Rubber Stamp, etc., if the name of the office is found modified in the reorganized jurisdictional chart.
12. After completing all the above formalities, compliance report may be submitted to the Commissioner by DC./AC of respective Divisions.

DISTRIBUTION OF POSTS IN TRICHY CUSTOMS COMMISSIONERATE.

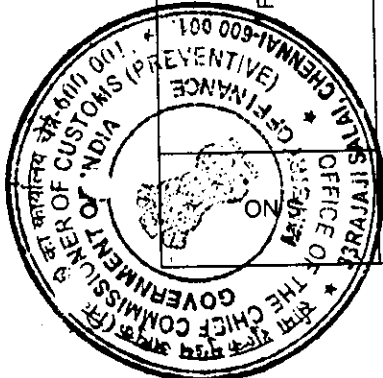
