PUBLIC NOTICE No. 03/2013

(Amendment to the Notification 01/2012 dated 16-11-2012)

Sub: Declaration of the Container Freight Station of M/S. Western Gateway Cargo Services (P) Ltd., Ambur for handling LCL export cargo-Reg.

Attention of Steamer Agents, Exporters, Importers, and their representatives (Customs Brokers) is invited to this office Notification No 1/2012 dated 16-11-2012 issued under Section 8(b) of the Customs Act, 1962, declaring the Container Freight Station of M/S. Western Gateway Cargo Services (P) Ltd. at 76-d, MC Road, Govindhapuram Village, Ambur, Vellore District as the CUSTOMS AREA FOR THE PURPOSE OF HANDLING FCL EXPORT AND IMPORT CARGO.

2. At the request of M/S. Western Gateway Cargo Services (P) Ltd. and in exercise of powers conferred under section 8(b) of the Customs Act, 1962, out of the total existing covered warehouse area of 9795 SFT, an area measuring 3390 SFT, adjacent to their office in the west, is demarcated for the purpose of Hub Point operation (consolidation of Export cargo). Consequently, the total warehouse area is relocated and amended as follows;

LCL (export) warehouse :3390 SFT;
FCL (export) warehouse :5405 SFT and
FCL (import) warehouse :1000 SFT.

3. M/S. Western Gateway Cargo Services (P) Ltd., the custodian, are hereby informed that

(i) they should provide separate sheds for LCL and FCL cargo and the export LCL cargo should be kept in the go-down allotted for the operation and should not be mixed with other FCL cargo;

(ii) the shed should be provided with 'Lock Fast Facility' for storage of sensitive cargo;

(iii) they should ensure that no hardship is caused to the importers/exporters and that

(iv) the procedures outlined in Board's Circular 55/2000 dated 30-6-2000 for the operation of Hub-Point operation(consolidation of Export cargo) and the provisions of Handling of Cargo in Customs Area Regulation (HCCAR), 2009 and the Customs Act, 1962 have to be followed.

4. This Public Notice shall come in to effect from 1-11-2013.
