- 4. The Officers who have not completed their station tenure in their present place of posting are not entitled for Transfer Benefits.
- If any of the above officers who have been finally selected and posted to Tuticorin Customs Commissionerate on SP 03 RB vide this Order fails to join duty at <u>Tuticorin Customs Commissionerate IN TIME</u>, the officer will be debarred from SP 03 RB for a period of 03 years from 2012.
