Attention of all is invited to the Notification No. 02/2012 dated 14.08.2012 notifying the CONTAINER FREIGHT STATION set up by M/s Chola Logistiks Pvt. Ltd., situated at No. 121, Harbour Express Road, Tuticorin as 'CUSTOMS AREA' under Section 8(b) of Customs Act, 1962.

Now, in exercise of the powers conferred under Section 8 (b) of the Customs Act 1962, the premises of CONTAINER FREIGHT STATION set up by M/s Chola Logistiks Pvt. Ltd., Tuticorin notified under Notification No. 02/2012 dated 14.08.2012 and subsequent Notification No. 04/2018 dated 11.12.2018 for inclusion of additional area, is partially modified for the inclusion of further additional area of 26,579 Sq. Ft. in Survey No. 962, Harbour Express Road, Tuticorin Situated at the West side of the existing CFS area for the purpose of de-stuffing of Import laden containers, storage & Customs examination of Import cargo as well as for the purpose of storage, Customs examination of cargo meant for export and stuffing into containers under the supervision of Customs.
