Sub: Special IGST Refund and Drawback Disposal Drive- Implementation of decision to expedite pending IGST refund and drawback claims-reg.

Attention of the Exporters, Custom House Brokers, All Carriers/Shipping Lines/Steamer Agents and all members of Trade is directed towards Refund of IGST paid on export of goods under Rule 96 of CGST Rules, 2017 and Refund of Duty Drawback under Section 75 of the Customs Act, 1962.


2. The CBIC has taken a number of measures to mitigate the hardship caused by the Covid-19 pandemic to the trade and industry and other stake holders. It has now been decided that all pending Customs IGST refund and drawback claims shall be expeditiously processed in order to provide immediate relief to the business entities especially MSMEs, This decision has been announced vide Press Note dated 08.04.2020 issued by Department of Revenue, Ministry of Finance and Instruction No. 03/2020-Customs dated 09.04.2020.

3. In view of the above instruction a "Special Refund and Drawback Disposal Drive" with the objective of priority processing and disposal of all pending refund and drawback claims is being launched by Tuticorin Customs. This drive shall be in place till 30.04.2020. It is expected that during this period all refund and drawback claims that are pending as on 07.04.2020 shall be disposed.

4. For pending IGST Refund, the exporters having Shipping Bills with Invalid Invoice Number Error (SB005) can submit application in terms of the prescribed format (Concordance Table) and required documents given in Circular 05/2018-Customs dated 23.02.2018 to the email ID of DBK Section dbktutcus@gmail.com from their official email ID.

5. If shipping bills have SB002 [EGM details error] or SB006 [Gateway EGM error], exporters shall file or rectify the EGM details at the Gateway Port. They may contact their respective shipping agents/Liner in this regard.

6. For DBK Refund pending due to queries in exporter's queue, the reply along with relevant documents may be submitted, so as to enable this office to process the Drawback.
7. Difficulty, if any, faced in the implementation of this Facility Intimation may be brought to the notice of the undersigned.
