NOTIFICATION NO. 01/2020

Sub: Appointment of M/s Central Warehousing Corporation, Tuticorin as Custodian for Direct Port Entry and Document Processing Zone in the Truck Parking Terminal for Export of Containerised Cargo under Section 141 of the Customs Act.1962 and Handling of Cargo in Customs Areas Regulations, 2009 as amended -Reg.

In exercise of the powers conferred under Section 8 (a) and 8(b) of the Customs Act 1962, the designated area at Survey No.952 with the following boundaries, situated inside the "Truck Parking Terminal" developed and set up by M/s VOC Port Trust at Harbour Express Road, opposite to Fisheries College, Tuticorin - 628 006 was notified as "CUSTOMS AREA" by this office vide Notification NO. 03/2018 dated 06.07.2018 for the purpose of Direct Port Entry of Containerised Export Cargo and Document Processing Zone under Customs examination and supervision .

2. Whereas the above said designated area notified as "Customs Area" has been given on lease to M/s Central Warehousing Corporation, Tuticorin by M/s VOC Port Trust for a lease period of 30 years and hence in exercise of the powers conferred under sub-section (2) of section 141 of the said Act read with Handling of Cargo in Customs Areas Regulations(HCCAR) 2009 as amended, M/s Central Warehousing Corporation, Tuticorin is appointed as the Custodian and Customs Cargo Service provider of the said "Customs Area", under Regulation 10 of the HCCAR,2009, for handling of Containerised Export Cargo and Document Processing Zone under Customs examination and supervision .

3. The Custodian/Customs Cargo Service Provider(CCSP) shall be required to comply with the provisions of the Customs Act 1962 as well as Rules, Regulations, Notifications, Orders, instructions etc., issued from time to time under the said act.
4. The custodian shall fulfil all the conditions and undertake all responsibilities as laid down in the "**Handling of cargo in Customs Area Regulations, 2009**" as amended. .
5. The Customs Cargo Service provider shall intimate the Customs about the schedule of charges for the various services provided by him in relation to the export goods in the customs area.
6. Duration of the appointment shall initially remain for a period of two years and subject to the satisfaction of the Commissioner of Customs. The Commissioner of Customs shall have the right to terminate the appointment at any time after assigning specific reasons and giving an opportunity for the custodian to explain his case. The appointment shall be reviewed before the expiry of the initial period of approval of two years and may extend such approval to a further period of five years at a time subject to the fulfilment of conditions as per Regulations 5 of the HCCAR, 2009.

DESCRIPTION OF THE AREA AND LOCATION OF PREMISES :

07. The area notified as "Customs area" measuring 18,357 Sqm at Survey No.952, situated within the premises of the Truck Parking Terminal owned, developed and set up by M/s VOC Port Trust and given on lease to M/s Central Warehousing Corporation with boundaries on four sides as noted below.

Northern Side : Survey No. 1659

Eastern Side : Survey No. 953 (953-1 & 953-2)

Western Side : 951(951-1& 951-2)(Truck parking Terminal)

Southern Side : Survey No.956 (956-1, 956-2 & 956-3)
