Subject: - Amendment in Export Policy of Onions.

Attention of all exporters/Custom Brokers/ Clearing Agents/Shipping agents/Trade and Industry is invited to the DGFT Notification No. 49 /2015-20 dated 02.03.2020 regarding the export of Onions.

2. Earlier the DGFT vide Notification No.21/2015-20 dated 29.09.2019 amended the export policy of onions from free to prohibited till further orders for the item description at Serial No.51 & 52 of Chapter 7 of Schedule 2 of ITC (HS) classification of Export & Import items.

3. In this regard, now the DGFT hereby has made the following amendment in Notification No. 21/2015-20 dated 29.09.2019 and Notification No. 46/2015-20 dated 06.02.2020 amending the Export Policy of Onion for the item description at Serial Number 51 & 52 of Chapter 7 of Schedule 2 of ITC (HS) Classification of Export & Import Items, with effect from 15th March, 2020.

4. Effect of this Notification:

The Export of all varieties of Onions, as described above, has been made "Free" without any condition of Letter of Credit (LC) and Minimum Export Price (MEP), with effect from 15th March, 2020. Accordingly, the Notification No. 46/2015-20 related to export of Krishnapuram Onions also stands withdrawn with effect from 15th March, 2020.
