Sub:- Notifying the additional inclusion of CFS Area of 9811.21 sq. mtr (2.42 acres) in respect of Container Freight Station setup by M/s. Sical Multimodal and Rail Transport Ltd., Tuticorin as 'CUSTOMS AREA' under section 8(b) of the Customs Act, 1962 - Reg.

Attention of all stakeholders, importers, exporters, customs brokers, steamer agents and liners is invited to the Public Notice No. 02/2011 and Notification No. 02/2011 both dated 21.04.2011 notifying the CONTAINER FREIGHT STATION set up by M/s Sical Multimodal and Rail Transport Ltd., situated at 1297/1-2, 3A-3B, Harbour Express Road, Opp. to SIPCOT Corporate Office, Madathur, Meelavittan Village, Tuticorin - 628008 as 'CUSTOMS AREA' under Section 8(b) of Customs Act, 1962.

2. Now, in exercise of the powers conferred under Section 8 (b) of the Customs Act 1962, the premises of CONTAINER FREIGHT STATION set up by M/s Sical Multimodal and Rail Transport Ltd., Tuticorin notified under Public Notice No. 02/2011 and Notification No. 02/2011 both dated 21.04.2011 are partially modified to the extent of inclusion of additional area of 9811.21 sq. mtr (2.42 acres) in Survey No. 1305/1 of Meelavittan Village, Tuticorin situated at the front side of the CFS area with existing two go-downs for the purpose of de-stuffing and stuffing of export cargo, storage of export cargo & Customs examination of cargo meant for export and stuffing into containers under the supervision of Customs.

3. The description of the CFS Area after inclusion of additional land area of 9811.21 sq. mtr (2.42 acres) taken on lease and location of the premises is as shown below;

**DESCRIPTION OF THE AREA AND LOCATION OF PREMISES:**

CFS Premises having an area of 56332.241 sq. mtr. (13.92 Acres) of land by M/s. Sical Multimodal and Rail Transport Ltd., Tuticorin situated in survey No. 1297/1-2, 3A-3B and 1305/1 on the Harbour Express Road, Opp. to SIPCOT Corporate Office, Tuticorin - 628 008, with boundaries on four sides as noted below.
