PUBLIC NOTICE NO. 02 /2021

Subject: Customs - IGST Scroll Rejection - Rectification by **Exporters - Reg.**

Recently, this Office has come across high and recurring instances of rejection of IGST Scrolls generated from this Commissionerate in respect of both INTUT 1 and INTUT 6 Ports resulting in denial of IGST benefits to a substantial number of exporters. This issue is attributed to the nonupdation of the bank particulars - specifically the IFSC Code by the exporters promptly in the EDI System consequent upon the recent merger of Nationalized Scheduled Banks. Even though the exporters have been sensitized to update their bank particulars, the frequency of rejection of IGST Scrolls still continues to be high.

- The entire IGST Scroll consisting of a large number of Shipping Bills 2. generated during a particular day(s) gets rejected on account of the said omission/mistake committed by one or a few exporters as a result of which the IGST benefits are denied to a substantial number of exporters who have updated their bank particulars correctly.
- The exporters are hereby informed to update their correct 3. bank particulars - specifically the IFSC Code, with the EDI System consequent upon the merger of Nationalized Scheduled Banks, urgently. The Status of different Banks consequent upon the merger is given below for ease of reference.
