PUBLIC NOTICE NO. 08/2022

Sub: Conduct of Online Examination under Regulation 6 of Customs Brokers Licensing Regulations, 2018 by the National Academy of Customs, Indirect Taxes and Narcotics (NACIN), Faridabad-Reg.

Attention of the Customs Brokers and all the members of the trade are invited to the above mentioned subject. The written examination of Customs Broker Licensing Examination, 2018 shall be conducted by NACIN, Faridabad in the month of March 2023 at the designated examination centers across India.

2. Applications are invited from Indian citizens to appear in the online written examination for issuance of license to act as a Customs Broker under Customs Brokers Licensing Regulations (CBLR), 2018, as amended. A copy of the regulations is available at www.cbic.gov.in and www.nacin.gov.in.

3. Complete application is to be submitted in person or by Registered/ Speed Post in Form-A (available in the CBLR, 2018) along with two passport size photos and self attested documents on citizenship (Aadhaar/ Passport/ Voter Card), educational qualification, financial viability, mobile number, e mail id and other requirements along with the prescribed fee of Rs.500/ (Rupees five hundred only) to the COMMISSIONER OF CUSTOMS, Custom House, New Harbour Estate, Tuticorin-628004 from 18.10.2022 to 18.11.2022 up to 06:00 p.m.. Applications sent by post, in case received after the last date shall not be entertained.

4. Before submitting the application, applicant should ensure the completeness of the application. Incomplete applications shall be summarily rejected.

5. The online written examination will be a Computer Based Exam with Multiple Choice Questions (MCQs) of two and half hours (10:30 hrs to 13:00 hrs) duration. Questions will be bilingual i.e. in English and Hindi.

The pattern of the examination will be as follows:

No. of questions : 150

Marking scheme : +3 for each correct answer

-1 for each incorrect answer

Maximum marks: 450

Qualifying marks: 270 (60%)

6. The syllabus of written examination will be as per regulation 6(7) of CBLR, 2018, as amended. Those qualifying in the said examination will have to appear for oral examination in terms of Regulations 6 of CBLR, 2018.

7. Successful candidates will be called for an oral examination for which separate communication will be sent by NACIN, Faridabad.

8. The oral examination will be held during the second quarter of the calendar year 2023. The pass percentage marks for qualifying in the oral examination will be 60%.

9. Attention is invited to the Guidelines dated 29.08.2018 issued by Ministry of Social Justice and Empowerment, Department of Empowerment of Persons with Disabilities (Divyangjan) and circulated by CBIC vide letter dated 10.10.2018 pertaining to the persons with benchmark disability. It is hereby advised that eligible candidates meeting this criteria of benchmark disability and willing to avail the benefit of these guidelines should appropriately intimate about their eligibility, and willingness so that necessary arrangements can be made by the exam conducting authority and its partner agencies.

10. A dummy question paper for the purpose of awareness of candidates will be made available on the CBIC and NICIN websites www.cbic.gov.in and www.nacin.gov.in under the icon/tab <GSTP/CBLR EXAM> from February, 2023. A link to download the admit card will also be provided therein. Admit card shall also be sent by e-mail to eligible applicants 12 days in advance before the date of examination. For convenience of candidates, other necessary details like list of centers, guidelines to the candidates, help desk, email id. Etc will also be made available under the said icon/tab.
