Attention is invited to Public Notice No. 03/2009 dated 07.09.2009 as amended vide letter dated 17.05.2012, issued by the Commissioner of Customs, Tuticorin declaring the Container Freight Station set up by M/s Continental Warehousing Corporation (Nhava Seva) Private Limited, Tuticorin as Customs Area under Section 8(b) of the Customs Act, 1962 and appointment as 'Custodians' for handling of Import and Export cargo under section 45(1) ibid read with Handling of Cargo in Customs Areas Regulations, 2009 (as amended). In this regard, it is brought to the notice of the Exporters, Importers, Customs Brokers, Shipping Lines, Freight Forwarders and all concerned stakeholders, that the name of M/s Continental Warehousing Corporation (Nhava Seva) Private Limited. has been changed to M/s DP World Multimodal Logistics Private Limited w.e.f. 30th of November, 2022.
