Sub: - Policy - Inclusion of additional area of 1.37 acres located in Survey No. 1272/1C and 1272/2 and declaration of Customs Area under Section 8 of Customs Act, 1962 - M/s. DP World Multimodal Logistics Private Limited, Tuticorin (formerly known as M/s. Continental Warehouse Corporation Private Limited (Nhava Seva)) – Reg.

Reference is invited to Notification No. 03/2009 dated 07.09.2009, letter C. No. VIII/13/22/2006-Cus. Pol dated 17.05.2012 and Notification No. 01/2014 dated08.2014 whereby 10.91 acres belonging to M/s. DP World Multimodal Logistics Private Limited, Tuticorin (formerly known as M/s. Continental Warehouse Corporation Private Limited (Nhava Seva)) was declared as "Customs area" under Section 8 (b) of the Customs Act, 1962.

2. Now, the Custodian of the above CFS, M/s. DP World Multimodal Logistics Private Limited, Tuticorin has requested for addition of 1.37 acres of land located in Survey No. 1272/1C and Survey No. 1272/2 to the existing Customs area of 10.91.

3. As the area is found suitable and provided with necessary infrastructure in consonance with the Regulations laid down in Handling of Cargo in Customs Areas Regulations, 2009, the new area is added to the previously declared "Customs area" of 10.91 acres and accordingly, para 2 of the Notification No. 03/2009 dated 07.09.2009 is amended as follows:

"Premises having an area of 12.28 acres of land owned by M/s. DP World Multimodal Logistics Private Limited, Tuticorin and its boundaries are mentioned below:"

BOUNDARIES:

North By: Land located in Survey Nos. 1271/2, 1271/3, 1271/4, 1271/5 and 1270/1.

South by: Vacant land located in Survey No. 1279/1, 1286 and 1277/1A1, 1277/1A2 & 1277/1B1.

East By: Land located in Survey No. 1276/1A & 1276 1B.

West By: Part of land located in Survey No. 1272/1C and 1272/2.
