It is for the kind attention of all trade and stakeholders that the Central Revenue Control Laboratory of Custom House, Tuticorin has been upgraded and accredited by NABL as per ISO:17025:2017. This laboratory is fully equipped to perform chemical analysis of Textile samples including testing of banned hazardous dyes.

2. It is instructed that all samples of textiles required for testing which are being sent to Textile Committee for analysis, may be sent to this laboratory as this lab is equipped to issue complete test reports for the same . Further, the test reports are being entered online in ICES System by the laboratory and hence the delay in receipt of reports is minimized. Thus there would be a reduction in dwell time.

3. The concerned CFS/Shed officers are instructed to denote the Lab Code as CL00TUT1 while generating the test memos for testing textile imports.

4. Difficulties faced, if any, may be brought to the notice of Additional/Joint Commissioner of Customs, Customs House, Tuticorin for necessary action.



During the conference, **Central Revenue Control Laboratory of Custom House, Tuticorin was highlighted for Specialized Testing Facilities of Textiles.** In this regard, it is to be mentioned that the Central Revenue Control Laboratory of Custom House, Tuticorin has been upgraded and accredited by NABL as per ISO:17025:2017. This laboratory is fully equipped to perform chemical analysis of Textile samples including testing of banned hazardous dyes.

It is learnt that the textile samples are being sent to Textile Committee for analysis which hereafter may be discontinued in order to reduce the dwell time. The concerned CFS/shed officers may be sensitized about this facility in Custom House Laboratory, Tuticorin and instructed to denote the **Lab Code as CL00TUT1** while generating the Test Memos for testing Textile Imports. The Trade/Importers/CHAs and the stakeholders concerned may also be sensitized by issuing a Public Notice regarding the Textile Testing facilities in Custom House Laboratory, Tuticorin.


Hence, it is requested that all samples of textiles required for testing may be sent to this laboratory as we are equipped to issue complete test reports for the same. Further, the test reports are being entered online in ICES system by the laboratory and hence delay in receipt of reports is minimized.

The thrust of the above Trade Facilitation Conference (Scientific Excellence for Seamless Trade) is largely to strengthen inter-agency coordination and address regulatory and procedural Challenges in cross border trade. It would include a Panel Discussion on Regulatory and Procedural Framework for Trade facilitation, involving regulatory bodies and industry experts including certain PGAs. The session will involve inputs from industry stakeholders and domain experts to develop collaborative solution.
