Attention of Importers, Exporters, Customs Brokers, Trade and all other stake holders is invited to the processing of Bills of Entry in ICES 1.5.

2. It is informed that new vendor M/s.Xeam Ventures Pvt., Ltd., has been awarded contract for running the Service Centre at Tuticorin Sea Port/ICD replacing M/s.CMC Ltd., from 01.10.2015 for two years.

3. The charges for digitisation of documents at service centre has been modified and the new rates are prescribed with effect from 01.10.2015 as follows:-
