Subject: Approval of M/s. ALS Tuticorin Terminal (P) Ltd, Tuticorin as Custodian under Section 45[1] of the Customs Act, 1962 and Customs Cargo Service Provider under Handling of Cargo in Customs Areas Regulations, 2009 as amended -Reg.

In exercise of the powers conferred under Section 45[1] of the Customs Act, 1962 M/s. ALS Tuticorin Terminal (P) Ltd, Tuticorin situated at Survey Nos: 998, Meelavittan Village, Behind Fisheries College, Harbour Express High Road, Tuticorin - 628 008, is approved as Custodian of all imported goods unloaded in the customs area as notified by Notification No. 01/2017 dated 16.05.2017.

2. In exercise of powers conferred under Regulation 10 of Handling of Cargo in Customs Area Regulations, 2009, M/s. ALS Tuticorin Terminal (P) Ltd, Tuticorin situated at Survey Nos: 998, Meelavittan Village, Behind Fisheries College, Harbour Express High Road, Tuticorin - 628 008, is approved as Customs Cargo Service provider for receipt, storage, delivery, dispatch or otherwise handling of imported goods and export goods in the said Customs Area.

3. The Custodian/Customs Cargo Service Provider(CCSP) shall be required to comply with provisions of the Customs Act, 1962, including provisions of Section 45 and Section 141 as well as Rules, Regulations, Notifications, Orders, instructions etc., issued from time to time under the said Act.

4. The Customs Cargo Service Provider shall fulfil all the conditions and undertake all responsibilities as laid down in "**Handling of Cargo in Customs Area Regulations, 2009**" as amended.

5. The approval granted under Regulation 10 of the said regulations, is initially for a period of two years, from the date of issue of the approval. The Commissioner of Customs will review the approval granted before the expiry of the initial period of approval of two years and may extend such approval to a further period of 5 years at a time in accordance with law. The Commissioner of Customs for reasons to be recorded in writing has the right to withdraw the approval granted before the completion of the period of approval.
