In exercise of the powers conferred under Section 45(1) of the Customs Act, 1962, M/s Tuticorin Coal Terminal Private Ltd., situated at NCB II Berth, VOC Port Trust, Tuticorin-628004 is hereby approved as the Custodian of all imported cargo unloaded in the North Cargo Berth II, which is within notified Customs Area of the VOC Port Trust, Tuticorin District-628004.

2. In exercise of the powers conferred under Regulation 10 of Handling of Cargo in Customs Area Regulations, 2009, M/s Tuticorin Coal Terminal Private Ltd., situated at NCB II Berth, VOC Port Trust, Tuticorin-628004 is hereby approved as Customs Cargo Service Provider for receipt, Storage, delivery, dispatch or otherwise handling of imported goods in the said Customs Area.

**3. Description of Area and Location:**

The Terminal North Cargo Berth II is located inside the VOC Port Trust Premises, with Berth Length of 306 Mtrs. Other Break-up is as below:

Wharf Area - 7007.4 Sq.Mtrs

Storage area- 17,500 Sq.Mtrs

Utilities - 500 Sq.Mtrs

**Boundaries:**

The Cargo Terminal with berth bounded at:

On the North: VOC Port Trust common Road

On the south: Sea


On the East: NCB I Berth

On the West: NCB III Berth

4. The Custodian/Customs Cargo Service Provider shall be required to comply with the provisions of the Customs Act, 1962 including the provisions of Section 45 and Section 141 as well as Rules & Regulations and instructions issued from time to time under the said Act.

5. The Customs Cargo Service Provider shall fulfil all the conditions and undertake all responsibilities as laid down in **Handling of Cargo in Customs Area Regulations, 2009** as amended.

6. The approval granted under Regulation 10 of the said Regulations is initially for a period of two years, from the date of issue of the approval. The approval granted will be reviewed before the expiry of the initial period of approval of two years and may be extended to a further period of 5 years at a time in accordance with law. The approval granted can be withdrawn at any time before the completion period of approval for the reasons recorded in writing.
