In exercise of the powers conferred under Section 45[1] of the Customs Act 1962 and sub-section (2) of section 141 of the said Act read with Handling of Cargo in Customs Area Regulations(HCCAR) 2009 as amended, M/s. Prompt Terminals (P) Ltd., Ayyanadaippu, Tuticorin Taluk, Tuticorin situated at Survey Nos: 22 Part, 23/1Part, 24/4 Part, 24/1 Part, 25/2 Part, 25/3 Part and 25/6 Part, Tuticorin - 628 101, is approved as the Custodian of all imported goods unloaded in the Customs Area as notified by Notification No. 1/2018 dated 18.01.2018.


2. In exercise of the powers conferred under Regulation 10 of Handling of Cargo in Customs Area Regulations (HCCAR) 2009 as amended, M/s. Prompt Terminals (P) Ltd., Ayyanadaippu, Tuticorin Taluk, Tuticorin situated at Survey Nos: 22 Part, 23/1Part, 24/4 Part, 24/1 Part, 25/2 Part, 25/3 Part and 25/6 Part, Tuticorin - 628 101, is approved as Customs Cargo Service Provider for receipt, storage, delivery, dispatch or otherwise handling of import and export goods in the said Customs Area.

3. The Custodian/Customs Cargo Service Provider(CCSP) shall be required to comply with the provisions of the Customs Act 1962 including provisions of Section

45 and Section 141 of the Customs Act, 1962 as well as Rules, Regulations, Notifications, Orders, instructions etc., issued from time to time under the said Act.

4. The Custodian/ Customs Cargo Service Provider (CCSP) shall fulfil all the conditions and undertake all responsibilities as laid down in "**Handling of cargo in Customs Area Regulations, 2009**" as amended.

5. The approval granted under Regulation 10 of the said Regulations is initially for a period of two years, from the date of issue of the approval. The approval granted will be reviewed before the expiry of the initial period of approval of two years and may be extended to a further period of 5 years at a time in accordance with law. The approval granted can be withdrawn at any time before the completion period of approval for the reasons recorded in writing.
